The meeting of the presbytery convened at 5:52pm. The Stated Clerk called the meeting to order with prayer because the previous co-moderators were not able to attend the meeting. Zoom procedures were reviewed. A quorum was present; (roll is attached). The agenda was approved as posted.

Moderator Rev. Greg Ellis and Vice-Moderator Pastor Rebecca Holland were installed by the Stated Clerk. The minutes of the previous meeting had been approved by the presbytery's standing rule and posted on the presbytery website. Guests and first-time commissioners were introduced.

Stated Clerk's Report

Stated Clerk Rev. Lillian Pak reported that the Clallam Bay Presbyterian Church's final worship service was held on June 25, 2023. The congregation was dissolved by the following administrative commission, who submitted their final written report on December 18, 2023 and are dismissed with gratitude: Rev. Carol McLaughlin, Moderator; Ruling Elders Donna Keys and Loreta Klock, Rev. Matt Paul, *FPC Port Angeles*, Rev. Bruce Cook, *Retired*.

Executive Presbyter's Report

E.P. Rev. Laura Terasaki shared a year in review coming up on 11 months as Executive Presbyter.

Treasurer's Report

Treasurer Matt Appel reviewed the financial reports distributed with the agenda and acknowledged the unintentional conversion of the \$ to €. The corrected report is attached. ii

Commission on Ministry Report

Moderator Rev. Elizabeth Shen O'Connor shared a report which included the *D*elegated Actions Report^{iv} and acknowledged pastoral transitions: Rev. Addie Domske, Snohomish FPC.CP George Eastman, *Neah Bay*, Rev. Ann Lewis, *Snohomish FPC*, Rev. Carol McLaughlin, FPC Quilcene, Rev.Cody Ryu, *Oak Harbor Korean PC*. Also, a special thanks was extended to all active pastors for completing the misconduct prevention training and a reminder of the pastoral annual review due at the end of March was given.

Examinations

Moderator Rev. Elizabeth Shen O'Connor introduced Bethany Grenfell as a Candidate for Ordination. She had been examined by an Exam Team according to the presbytery's process who had reviewed her written responses, which were subsequently distributed to the presbytery with the agenda, and had examined her orally. There were no items discovered during the oral examination that the Examination Team believed should be disclosed to the presbytery. The recommendation of the team was to proceed to ordination.

The Candidate made a brief statement of faith. The presbytery continued to examine her 'Christian Faith and views in theology, the Bible, the Sacraments, and the government of the church.' A motion to end the examination was approved.

After excusing the candidate and discussion, the presbytery APPROVED the following resolution: "Resolved, That Bethany Grenfell is ordained in the validated ministry of Chaplain at Wenatchee Rescue Mission and received as minister member of the Northwest Coast Presbytery." The Commission on Ministry will designate an administrative commission to conduct a service of ordination.

Moderator Rev. Elizabeth Shen O'Connor introduced Rev. Dr. Jeff Gephart of Seattle Presbytery to be examined and received as a new minister member. His written responses were distributed to the presbytery with the agenda. The candidate offered a brief statement of faith. There was one question of examination and the motion to end the examination was approved. After excusing the candidate and discussion, the presbytery APPROVED the following resolution: "Resolved, That Rev. Dr. Jeff Gephart be examined and received as minister member serving as installed pastor at Lake Forest Park Church."

Moderator Rev. Elizabeth Shen-O'Connor welcomed the new members with prayer.
