Presbytery of the Northwest Coast
Minutes of the Stated Meeting
February 11, 2016
Cascade View Presbyterian Church, Everett, WA

The meeting was called to order and opened with prayer at 12:30 p.m. by Stated Clerk Rev. Dean Strong, in the absence of the past moderator or the vice moderator.

The presbytery proceeded immediately to the installation of the Rev. James Joon Kwon, Pastor of Community Church of Seattle/Hungjae Church, as moderator. Executive Board Moderator Rev. Kurt Helmke and Executive Presbyter Elder Dr. Corey Schlosser-Hall led the service of installation.

Worship was led by host interim Pastor Rev. Ted Schuldt. Candidate for ordination and Pastor elect of Sunnyside Presbyterian Church, Mr. Michael Souza, preached a sermon entitled *Seeing Doc Graham*, on Luke 9:28-36. Rev. Schuldt presided over the sacrament of the Lord's Supper and the presbytery was served by the elders of Cascade View.

Elder Lorrie Nelson spoke about the mission and ministry of the host congregation, and especially about the excitement surrounding their newly called pastor who was soon to arrive. The moderator led the presbytery in prayer aloud for Cascade View.

At the conclusion of worship, the moderator opened the business meeting. A quorum was present.<sup>1</sup> The agenda and the minutes of the October 16, 2015 meeting were approved as distributed. Members of other presbyteries were recognized and greeted. Commissioners attending a presbytery meeting for the first time were introduced. Commissioners present from Central Washington Presbytery were recognized. The presbytery greeted those attending on-line who were located in Eastern Washington, northern Washington, and Alaska.

### **Stated Clerk's Report**

The Rev. Dean Strong reported by thanking the host congregation and those who had assisted with the logistics of the meeting.

<u>Bylaw Amendments</u> – The following amendments were proposed and presented to the presbytery at the previous stated meeting. The Stated Clerk explained that the amendments were to provide more flexible operation as the presbytery seeks to administrate three former presbyteries covering a tripled geographical area over great distance. The presbytery APPROVED the amendments, the complete text of which is attached.<sup>2</sup>

- 6.100 Removes requirement for four stated meetings a year.
- 4.100 Officers serve until successors have been elected.
- 4.400 Moderator of the Executive Board elect by the Board.
- 4.600 Stated Clerk nominated by the Nominating Committee.
- 7.000 Membership of Boards, Commissions, or Committees vacated after two successive unexcused absences.
- 8.300 Immediate past presbytery moderator still a member of the Executive Board, though not automatically the Board Moderator, see 4.400 above.
  - 8.500 Provides for call of a special meeting of the Board if the Moderator absent or unable.
  - 15.000 Bylaws may be amended by 2/3rd vote with ten days notice of the meeting

<u>Financial Reports</u> – The presbytery reviewed the Statements of Financial Position and Activity for the period ending December 31, 2015.<sup>3</sup>

### **Presbytery Executives**

Dr. Corey Schlosser Hall, Executive Presbyter of Northwest Coast Presbytery provided an overview of how the merger with Central Washington Presbytery is being executed. The two presbyteries are effectively operating as one, with all functions and the finances having been merged already. The official merger will occur with a vote of the General Assembly, and the corporation merge will occur after the G.A. vote.

The Rev. Kevin Nollette, Transitional Executive of Central Washington Presbytery, explained how the operations of Central Washington are being transferred to Northwest Coast and that his position will end in June.

### **Executive Board**

Board Moderator Rev. Kurt Helmcke reported. The minutes of the regular meetings of December 19, 2015 and January 22, 2016 were distributed with the agenda. Rev. Helmcke recognized those serving on the Board who were present (both in the room and online), and invited the presbytery to provide them with input and ideas.

The following is a summary of the major actions of the Board as distilled from the minutes:

- Scholarships for pastors to participate in the Oasis Project sponsored by Renewal Ministries NW;
- GA Commissioners were elected: Bill Simpson, Shannon Smythe, James Kwon, Amy Delaney; YAAD Jessamine Anderson;
- The merger with Central Washington Presbytery continues to be executed;
- A strategy for developing a potential new church has been approved;
- The Stated Clerks role has been expanded temporarily to address new communication technologies, database information systems, and financial management & interpretation;
- A Conflict of Interest Disclosure Policy for Board members has been adopted;
- An infrastructure task force for future staffing, technologies, facilities, and policies has been appointed.

### **Examinations and Introduction of New Members**

Michael Souza Ordination – The Rev. Dennis Hughes reported that Candidate Michael Souza had been examined by the Commission on Ministry of Central Washington Presbytery, and that his exam would be continued before the presbytery according to policy and tradition. The candidate addressed the presbytery and provided a brief statement of faith and commitment to the ministry of the Word and Sacrament. The presbytery examined him further on his Christian faith and views in theology, the Bible, the Sacraments, and the government of the church. A motion to end the examination was approved. After excusing the candidate, and after discussion, the presbytery APPROVED the recommendation, that Candidate Michael Souza proceed to ordination and installation as Pastor of the Sunnyside Presbyterian Church. The Commission on Ministry will designate an administrative commission to conduct a service of ordination and installation.

The Rev. Janet Sonnanburg, of Seattle Presbytery, is serving as Interim Pastor of Saint James Presbyterian Church with the approval of the Commission on Ministry. She was examined by the Exam Team according to the presbytery's process, MMM 4.4201, reviewing her written responses, which were distributed to the presbytery, and orally examining her according to Christian faith and views in theology, the Bible, the Sacraments, and the government of the church. There were no items discovered during the oral examination that the Examination Team believed should be disclosed to the presbytery.

Rev. Sonnanburg offered a brief statement of faith and her commitment to the ministry of the Word and Sacrament. Members of the presbytery continued the examination until a motion to end the examination was approved. After discussion, the Team's recommendation that she be received as a member was APPROVED.

Normington/Waterville – The Rev. Seth Normington has been called as Pastor of Waterville, WA, Federated Church. He was previously examined by the Commission on Ministry of Central Washington Presbytery and received as a member. He addressed the presbytery, offering personal background, his passion for ministry, and explaining that the Waterville Church was the consolidation of the Methodist, UCC, Presbyterian and American Baptist congregations generations ago, and that its pastors rotate among those denomination. Rev. Normington is the first Presbyterian Pastor to serve there since 1985.

<u>Heins/Port Townsend</u> – The Rev. Paul Hines was called and installed as Pastor of the First Presbyterian Church of Port Townsend, having been examined last summer by a team and then by the full membership of the Commission on Ministry. Since he has been unable to attend a presbytery meeting since being called and installed he was introduced to the presbytery. He shared his background, faith and commitment to the ministry of Word and Sacrament in Port Townsend.

The presbytery gathered around these new members, laid hands on them, and prayed for them. The Rev. Doug Bunnell then led them in the obligatory quiz regarding Northwest places and traditions, and presented them with "parting gifts."

Luke Hyder as Pastor and moderator of the session of Cascade View, beginning March 1, 2016, upon successful examination and recommendation that he be received as a member of the presbytery, according to the following terms: Cash and Housing Allowance: \$62,000, Reimbursable Business Expenses: \$1,500, Continuing Education: \$1,500, Full Board of Pensions Benefits, Annual Study Leave: 14 days, Vacation: 30 days, Moving Allowance: Actual expenses not to exceed \$12,000.

<u>Coulee Dam</u> – The minutes of the closing Administrative Commission are attached to these minutes as actions of the presbytery.<sup>4</sup>

<u>David Ro/Ordination Commission</u> – December 10, 2016; Rev. Dianne, Kunce, Rev. Denise Easter, Kevin Shin, Lorrie Nelson, Rev. Neil Trainer.

Mount Baker/Smith - Appointed CRE Janice Smith as moderator of the session.

Saint James/Sonnanburg – Approved the interim contract between the session and Rev. Janet Sonnanberg.

<u>Sunnyside/Souza</u> – Approved the call to Candidate Mike Souza and appointed him moderator of the session until he is ordained and installed, upon vote of the presbytery that he proceed to ordination and installation, according to the following terms: Cash Salary: \$24,000.00, Housing & Utilities Allowance: \$18,545.00 Social Security offset: \$3254.72; Reimbursable Business Expenses Auto/Travel: \$1,500, Books/Journals: \$600, Professional Expenses: \$1,500, Continuing Education: \$600; Full Board of Pensions Benefits, 35 days annual vacation, two weeks annual study leave, moving expenses up to \$7,500.

The Rev. Frank Baresel, Moderator, reported.

<u>Greider/Candidacy</u> – The Rev. Baresel reported that Inquirer Heidi Greider, member of Emmanuel, had been received as a Candidate by the Commission on December 3, 2015 as authorized by the bylaws. He presented her to the presbytery, and she shared a personal statement with respect to her Christian Faith, forms of service undertaken; motives for seeking the ministry. After further questions, Rev. Baresel administered the Constitutional questions for Candidates, offered a charge, and led the presbytery in prayer for Ms. Greider.

### **General Assembly Overture Concurrence**

G.A. Overture 012 is On PC(USA) Fossil Fuel Divestment–From the Presbytery of San Francisco. The overture "Call[s] upon the Board of Pensions and the Presbyterian Church (USA) Foundation to: a. Immediately stop any new direct investment in fossil fuel companies b. Work to ensure that within three years, none of the Board's or the Foundation's directly held or commingled assets includes holdings of either equities or corporate bonds in the fossil fuel companies identified in the Carbon Underground 200 . . ."

A Resolution that the presbytery concur with the overture was received by the Stated Clerk from the sessions of the First Presbyterian Church of Everett and Terrace View Presbyterian Church. After discussion, the resolution was APPROVED.

After some brief announcements, the meeting was adjourned with prayer by the Moderator at 3:17 p.m.

### Presbytery of the Northwest Coast Amendments to the Bylaws Approved February 11, 2016

**6.100 Stated Meetings** shall be held in accord with G-3.0105, at <del>least four times a year</del>, and shall constitute meetings of the corporation. One meeting shall be designated as the annual meeting when elections shall occur.

Rationale: The Book of Order requires presbyteries to meet at least twice a year. We are moving toward a large, face to face annual meeting, with other meetings held during the year as needed. There is no need to restrict our meeting schedule beyond the Book of Order.

**4.100.** Officers of the Presbytery shall be a Moderator, Moderator-Elect, Moderator of the Executive Board, Stated Clerk, and Treasurer. These officers shall perform the duties prescribed by these Bylaws, the Constitution, and Robert's Rules of Order. Terms of office shall begin January 1<sup>st</sup> and end on December 31<sup>st</sup> of the appropriate year, or until their successors have been elected.

Rationale – This allows for the continuation of an office, if for some unforseen reason, an election does not occur.

**4.400** Moderator of the Executive Board – A Moderator of the Executive Board shall, at its first meeting of the year, elect a moderator from its own members, be elected at the annual meeting for a term of who shall serve in the office for one year, beginning January 1 of the year following the election or until a successor has been elected. The nominee for Moderator of the Executive Board shall be the Moderator of the Presbytery at the time of the election. Should the office become vacant, a candidate shall be nominated by the Nominating Committee and presented for election at the next stated meeting. the Board shall elect from its own members a moderator to complete the term of the previous moderator.

As revised for easier reading: **4.400 Moderator of the Executive Board** – The Executive Board shall, at its first meeting of the year, elect a moderator from its own members, who shall serve in the office for one year, or until a successor has been elected. Should the office become vacant, the Board shall elect from its own members a moderator to complete the term of the previous moderator.

Rationale: The current processes forces the presbytery moderator to serve as the Board moderator, yet moderating the Board requires a different skill set, and a greater commitment to managing the day to day operations of the presbytery. The Board should be able to choose its own moderator, who, if gifted at it, could serve as long as he or she serves on the Board.

**4.600 Stated Clerk** a. Nomination to the office of Stated Clerk shall be by a committee comprised of a member of the Commission on Ministry, a member of the Commission on Preparation for Ministry, a Clerk of Session, a member of the Executive Board representing personnel matters, a member of the Executive Board representing leadership matters, and the moderator of the Nominating Committee, who shall be the committee's moderator. the Nomination Committee.

Rationale: This clause was inserted in the bylaws at the insistence of former a interim executive who had issues with the office of Stated Clerk. In resent years, the Stated Clerk has been nominated by the Nominating Committee, which is the appropriate process consistent with the Book of Order.

### **7.000 ORGANIZATION & STRUCTURE** - The structures of the Presbytery are:

d. When any member of an entity of the presbytery, a board, commission, unit, division, committee, task force, or any other body authorized by the presbytery or its Executive Board does not attend two successive sessions of that body and such absence is unexcused, the membership of that person shall be automatically vacated, and that person shall be notified by the Stated Clerk. The Stated Clerk shall be notified of the vacancy by the chairperson of the entity, and the Stated Clerk shall announce the vacancy and shall notify the Nominating Committee or other body that originated the nomination, election or appointment of the person who has been absent without excuse, in order that the vacancy may be filled in the manner by which the same position had been filled originally.

Rationale: this amendment is taken nearly word for word from the Standing Rules of the General Assembly. It provides a means to replace person who, for whatever reason, are unable to fulfill the commitment made to serve, which also prevents others who are willing an able to fill seats that have been, for all practical purposes, vacated.

**8.300** [Executive Board] Composition - The Board shall be composed of the Moderator Elect, the current Moderator of the Presbytery, and the Moderator of the Presbytery Executive Board immediate past Moderator of the Presbytery, and no fewer than nine men and women elected by the Presbytery from Alaska and Washington. Members shall be teaching elders in good standing or ruling elders; at least one half of the members shall be ruling elders. It shall conform to the principles of unity in diversity established in F.1-0403. The Stated Clerk, who shall serve as clerk of the Board, Executive Staff and the Treasurer shall be ex-officio members without vote for the duration of their service.

Rationale: This maintains the three year term on the Board of presbytery moderators, but allows for the Board to elect its own moderator.

**8.500 [Executive Board] Meetings -** The Board shall meet not less than prior to every stated meeting of Presbytery. The Moderator may call a special meeting of the Board when he or she judges it necessary and shall do so when requested in writing by any two members . <u>In the absence or incapacitation of the Moderator</u>, the Stated Clerk may convene a special meeting when requested in writing by any three members. Except in the case of an emergency, at least three days notice shall be given.

Rationale: Last summer when the Moderator was out of the country and out of touch, there was a need to call a special meeting but there was no provision in the bylaws. A provision for adequate notice is appropriate to prevent a small group from calling a meeting during a time when many members could not attend.

**15.000 AMENDMENTS** – The Bylaws may be amended at any stated meeting of Presbytery by a two-thirds vote, provided that <u>notice of a proposed amendment is provided in writing or by electronic means to the presbytery at least ten days prior to the meeting and than the exact proposed changes <u>are included</u>, were by an action of or were presented in writing at the previous stated meeting. in the notice.</u>

Rationale: Allowing for bylaw amendments only at stated meetings when presented at the previous stated meeting works well for societies that meet monthly and at least quarterly. Our presbytery is moving toward less frequent stated meetings, and calling meetings when needed. This amendment allows for more flexibility, especially during a time when the presbytery is changing and merging, yet it allows for adequate protection from inappropriate amendments or gerrymandering.

COULEE DAM ADMINISTRATIVE COMMISSION Telephone Conference Call January 20, 2016

The Coulee Dam Administrative Commission met via conference telephone call on January 20, 2016. The Moderator, TE Muriel Brown, opened the meeting with prayer at 10:05 a.m. Present in addition to the Moderator were RE Jerry Kennedy, RE Steve Syre, and Stated Clerk RE Mike Nixon (ex officio without vote). Absent were TE Becky Anderson and RE Jim Irwin and Interim Presbytery Executive TE Kevin Nollette (ex officio without vote).

The purpose of the meeting was to deal with some issues that Jerry had raised in a memo that accompanied his year-end financial report.

Regarding an audit of the church books, it was decided that yes there should be an audit/financial review. It was decided that Mike would contact Lynda Mikkelsen about doing this work for us. And that she and Jerry together would decide the number of years to review.

The Commission VOTED to name Steve Syre as an additional signatory on the checking account, but still requiring only one signer. The Commission decided that there was no good reason at this time to transfer some (or all) of the funds to the Presbytery for disbursement while the presbytery merger process is going on. Steve raised the possibility of Jerry receiving some remuneration for his work as treasurer, but Jerry refused to consider that.

It was decided that the Per Capita Invoice for NW Coast Presbytery for \$1429.50 should be paid in full, seeing no reason to request a lesser amount.

The fellowship hall roof was leaking again. Bob Hendrickson, a local man with a Handyman business that is a licensed contractor, has been asked to check that out. He might be called on for additional problems that develop. Jerry was authorized to make arrangements as necessary for the roof and possible sidewalk snow removal.

The estimate from the locksmith for changing all the outside door locks came in at \$100, so Jerry has made those arrangements. It was decided that extra keys would be available (for pick up and return) at Jerry's office (Foisy Kennedy, on the main drag coming through Grand Coulee—across from Safeway) for commission members and others who may need to get into the church building at some point.

Jerry offered his phone number for CenturyLink's referral intercept service. This will cut down considerably on phone bills, but still allow for knowing in timely fashion about possible pastoral care needs and persons who may be interested in the building.

The Commission decided to keep the dumpster until the end of February as Susan Kennedy and a preschool teacher are still cleaning out stuff.

There have been a couple of inquiries about the building, including one from the pastor at the Almira Community Church, which draws people from a rather large surrounding area, and might want to consider a satellite site at the Dam. Jerry had to leave the phone call at 11:00, so Mike will check with him to see if he has requested a title report yet.

Mike and Muriel talked some about membership issues and whether there is some kind of letter that should go to the remaining members to explain in writing about their membership being held by the presbytery and whom to contact when they have decided on a new church home, etc.

The conference phone call ended at 11:30 a.m.

### COULEE DAM ADMINISTRATIVE COMMISSION

Minutes

December 14, 2015

The Commission held its first meeting at the home of Jerry and Susan Kennedy in Electric City on December 14, 2015. The meeting was convened with prayer by the AC Moderator TE Muriel Brown. In addition to the Moderator the following AC members were present: TE Becky Anderson, RE Steve Syre, and RE Jerry Kennedy, RE Mike Nixon (Presbytery Stated Clerk, ex officio without vote) and TE Kevin Nollette (Interim Presbytery Executive, ex officio without vote). Absent was RE Jim Irwin. Also present was RE Susan Kennedy, clerk of the Coulee Dam Session.

The Commission spent time in getting acquainted with each other and the duties assigned to the Commission. The Administrative Commission is authorized to:

- a. Assume original jurisdiction if the Session is unable to oversee the ongoing life of the Coulee Dam Church before the effective date of the closure;
- b. Work with the session in helping members to transfer their membership to other churches;
- c. Develop a plan for providing pastoral care for those whose membership has not been transferred by the date of dissolution;
- d. Make declaration to the congregation and others according to need that the property and other assets of the church belong to the Presbyterian Church (USA) and that the Presbytery will hold them in trust when the congregation is dissolved. The committee will ensure that all titles of property, beneficiaries of trusts and endowments are changed over to the Presbytery, and that all accounts payable and receivable will be changed to the name of Presbytery;
- e. Consult with the session regarding the disposal of equipment, memorials, etc.
- f. Consult with the session regarding which records of the Session are to be turned over to the Presbytery at the time of dissolution;
- g. Take necessary steps to dissolve the corporation in accord with the laws of the State of Washington;
- h. Ensure that all liabilities, including financial obligations, are satisfied from the assets of the Coulee Dam Community Church prior to its dissolution;
- i. Make a final report to the Presbytery along with enabling motions to close all matters related to the Coulee Dam Community Church.

Upon motion by Steve Syre, the Administrative Commission VOTED to assume original jurisdiction with full powers of the Session on January 1, 2016.

Jerry Kennedy agreed to continue on as Treasurer. There was general discussion regarding the need to secure the building, changing locks, seeing about roof repair, doing a title search, providing pastoral care to remaining members, etc. Susan Kennedy will see that there is a

monthly Bible study/prayer meeting held in the church building so that the property will still qualify for tax exempt status as used for "religious purposes."

The Administrative Commission ended with prayer at 5:30 p.m. as we were joined by members of the Session for a light supper, which was followed by their Session meeting.

# Presbytery of the Northwest Coast Minutes of the Stated Meeting May 19, 2016 First Presbyterian Church of Kennewick, WA

The presbytery gathered for registration and fellowship beginning at 10:00 a.m. At 11:00 a.m. the following workshops were held:

Ministry & Life in the Democratic Republic of Congo, Ruth Brown, PC(USA) Mission Co-Worker;

Ministry & Life in the Middle East, Jonna Reeder, PC(USA) Mission Co-Worker;

Contemporary Cuba and the Christian Church, Rev. George Pasley, Ketchikan PC will share about his February 2016 trip to Cuba;

The Campbell Farm: Loving our Neighbors as Ourselves, Carmanita Pimms.

*Meeting Issues Background: Focus & Infrastructure Task Force; Mukilteo Dismissal Request*, Rev. Kurt Helmcke & Rev. Amy Delaney.

The presbytery recessed for lunch.

After lunch worship was led by host Associate Pastor Rev. Ashley Birk. The Rev. Gustavo Carvajal preached. Elders Bill Simpson, Shannon Smythe, Rev. James Kwon, Rev. Amy Delaney, Jim Irwin, Rev. Bob Johnson, and YAAD Jessamine Anderson were commissioned to serve on behalf of the presbytery at the upcoming General Assembly. Rev. Birk presided at the Lord's Supper, which was served by Julie Epperly, Dale Clark, Dave Burrill, Mark Benecke, and Dianne Macduff.

At the conclusion of worship, Moderator Rev. James Kwon began the stated meeting at 3:15 p.m. with prayer. A quorum was present.<sup>1</sup> The agenda and the minutes of the February 11, 2016 meeting were approved as distributed. Members of other presbyteries were recognized and greeted. Commissioners attending a presbytery meeting for the first time were introduced.

### **Stated Clerk's Report**

The Rev. Dean Strong reported by thanking the host congregation and those who had assisted with the logistics of the meeting.

The following reports were received: 2015 Statistical Reports<sup>2</sup> for both predecessor presbyteries, Presbytery Commissioners Determined by Reported Statistics;<sup>3</sup> 2015 Reported Necrology.<sup>4</sup>

<u>Financial Reports</u> – The presbytery reviewed the Statements of Financial Position and Activity for the period ending March 31, 2016.<sup>5</sup>

<u>Coulee Dam Community Church Administrative Commission</u> – The following resolution was APPROVED: "That the Coulee Dam Community Church Closure Administrative Commission be authorized to execute the final disposition of all property, equipment and assets, including the sale of real property." The full text of the commission's tasks and duties, as amended, is attached to these minutes.<sup>6</sup>

### Presbytery Executive

Dr. Corey Schlosser Hall gave thanks for the service of the staff of Central Washington Presbytery. Stated Clerk Mike Nixon was recognized by the presbytery. Transitional Executive Rev. Kevin Nollette was unable to be present as he was recovering from a concussion suffered while unloading a fireproof cabinet trucked from the Central Washington office to the Northwest Coast Office. The presbytery offered prayers for his recovery.

### **Board of Pensions**

The Rev. Mark Frey addressed the presbytery and spoke about the new services being offered by the Board.

### **Executive Board**

Board Moderator Rev. Kurt Helmcke reported. The minutes of the Northwest Coast Executive Board meeting of April 21<sup>st</sup> and the Central Washington Presbytery Council meeting of March 18<sup>th</sup> were distributed with the agenda.

The following is a summary of the major actions of the Board as distilled from the minutes:

- A task force is addressing the presbytery's future focus and infrastructure;
- Rev. Jinsuk Kim is serving Korean congregations throughout the synod;
- A review of the Mission Partners covenants is being conducted;
- The Deming property is for sale;
- A major Community Blessing Grant was awarded to build more houses in Pateros, WA.

### **Examinations**

The Rev. Dennis Hughes reported that each of the following candidates for ordination and/or presbytery membership had each been examined by a team according to the presbytery's policy; there were no items discovered during these oral examinations that the Examination Team believed should be disclosed to the presbytery, and that the respective exam teams had all recommended approval:

Rev. Luke Hyder, of Chicago Presbytery, to be installed as Pastor of Cascade View Presbyterian Church;

Rev. Young Rae Lee, of Chicago Presbytery, to be installed as Pastor of Zion Presbyterian Church;

<u>Candidate Yo Kim</u>, of San Francisco Presbytery, to be ordained and installed as Associate Pastor of the United Presbyterian Church of Seattle;

<u>Candidate Matt McCoy</u>, of Northwest Coast Presbytery, to be ordained as Chaplain of St. Paul's Episcopal Academy in Bellingham;

<u>Rev. Doug Waltar</u>, of Inland Northwest Presbytery, serving as Executive Director of Ingalls Creek Enrichment Center in Peshastin, WA.

Each of the five candidates addressed the presbytery and provided a brief statement of faith and commitment to the ministry of the Word and Sacrament. The presbytery examined them further on "Christian faith and views in theology, the Bible, the Sacraments, and the government of the church." A motion to end the examination was approved. After excusing the candidates and discussion, the presbytery APPROVED the recommendation that these candidates be received as members and/or proceed to ordination and installation as indicated above. The Commission on Ministry will designate administrative commissions to conduct the respective services of ordination and/or installation.

The presbytery gathered around these new members, laid hands on them, and prayed for them. The Rev. Doug Bunnell then led them in two further "examinations," *Old Testament Emoji*, and "*Is it Lamentations or a Taylor Swift Lyric*." The Rev. Bunnell awarded each of the new members prizes, awards, and parting gifts for their excellent quiz performances.

### **Commission on Ministry (COM)**

The Rev. Amy Delaney, Co-Moderator, reported.

Mukilteo Dismissal – The presbytery APPROVED the *Plan for the Dismissal of Mukilteo Presbyterian Church*<sup>7</sup> and designated Ruling Elders Karen Butler, *North Creek*, Kristen Hitchcock, *Calvin*, Steve Syre, *At-large*, Teaching Elder Dennis Hughes, *HR* and two Teaching Elders to be named by the Executive Board as an Administrative Commission to execute the plan and assume the responsibilities and powers delineated therein.

<u>Mung Sung Name Change</u> – The following resolution was APPROVED, "That the Myong Sung Presbyterian Church be permitted to change their name to *The Lord of Glory Presbyterian Church*."

<u>Recognition of Service for Retiring Pastors</u> – Rev. Ted Mattie, Pastor of the First Presbyterian Church of Port Angeles, and the Rev. Bob Johnson of the Meadow Springs Presbyterian Church of Richland were recognized for the faithful service. Both plan to retire in the coming months.

### **Authorized Actions Reported to the Presbytery:**

<u>Acme/Smith</u> – CRE Janice Smith's commission to Acme Presbyterian Church was RENEWED for three years, effective April 7, 2016.

<u>Ingalls Creek/Rev. Doug Walter</u> is a member in good standing of the Presbytery of the Inland Northwest and Executive Director of Ingalls Creek Enrichment Center in Peshastin, WA. He is seeking membership, and upon successful examination and reception as a member, he is permitted to engage in this work as a validated ministry beyond the jurisdiction of the church (See Examinations).

<u>Quilcene/Schaefer</u> – On March 3<sup>rd</sup>, COM CONCURRED with the congregation and dissolved the pastoral relationship with the Rev. Scott Schaefer, also disapproving him for the work of validated ministry described in G-2.0503a until remedial, healing and reconcilatory work has been completed.

<u>Quilcene/Hughes</u> – The session's request to establish a temporary pastoral relationship with the Rev. Dennis Hughes was APPROVED.

<u>Sunnyside/Souza</u> – The following were DESIGNATED as an Administrative Commission to Ordain and Install Mike Souza as Pastor of Sunnyside Presbyterian Church, April 23, 2016, 1:00pm: Elder Sam Dechter *Kennewick First*, Elder Heidi Saikaly *Mukilteo*, Elder Sarah Heeringa *Sunnyside*, Rev. Bob Johnson *Meadow Springs*, Rev. Gustavo Carvajal *Parker Heights*, Rev. Jim Calkins *HR*.

St. Paul's Academy/Candidate Matt McCoy – Certified Candidate Matt McCoy's call as Chaplain of St. Paul's Episcopal Academy in Bellingham was recognized as a call to validated ministry requiring ordination as a teaching elder upon successful examination for proceeding to ordination and reception as a member of the presbytery (See Examinations).

### **Coulee Dam Community Church**

#### **Closure Administrative Commission**

On recommendation from the Committee on Ministry, Presbytery Council VOTED at their November 20, 2015 Council meeting to appoint an Administrative Commission to oversee the closing of the Coulee Dam Community Church. Members of the Commission are Rev. Muriel Brown, moderator of Coulee Dam's session; Rev. Becky Anderson, interim Head of Staff at Othello; Elder Jim Irwin, Moderator of Presbytery Council; Elder Steve Syre, member of Council; and either Elder Susan Kennedy or Elder Jerry Kennedy of the Coulee Dam Church. Rev. Kevin Nollette, Interim Presbytery Exec and Michael Nixon, Stated Clerk will serve as support to the Commission. The Commission shall be authorized to:

- a. Work with the session in helping members to transfer their membership to other churches as appropriate.
- b. Develop a plan for providing pastoral care for those whose membership is not being transferred by the date of dissolution.
- c. Work with the pastor and session in planning a final service of worship and celebration of the history of the Coulee Dam church, noting it is the desire of the Coulee Dam Session to have their last worship service prior to the end of 2015.
- d. Make declaration to the congregation and others according to need that the property and other assets of the church belong to the Presbyterian Church (USA) and that the Presbytery will hold them in trust when the congregation is dissolved. The committee will ensure that all titles of property, beneficiaries of trusts and endowments are changed over to the Presbytery, and that all accounts payable and receivable will be changed to the name of Presbytery.
- e. Consult with the session regarding the disposal of equipment, memorials, etc.
- f. Consult with the session regarding which records of the Session are to be turned over to the Presbytery or deposited with the Presbytery Historical Society at the time of dissolution.
- g. Take necessary steps to dissolve the corporation in accord with the laws of the State of Washington.
- h. Ensure that all liabilities, including financial obligations, are satisfied from the assets of the Coulee Dam Community Church prior to its dissolution.
- i. Make a final report to the Presbytery along with enabling motions to close all matters related to the Coulee Dam Community Church.
- j. <u>execute the final disposition of all property, equipment and assets, including the sale of</u> real property.

## Commission on Ministry Plan for Dismissal of Mukilteo Presbyterian Church Approved by the Presbytery: May 19, 2016

In recognition of the significant theological perspectives that divide us, the desire to avoid further disagreement, the need for focus on the evangelization of the Mukilteo Community, and the individual call on the congregation of the Mukilteo Presbyterian Church (MPC), the Commission on Ministry (COM) recommends:

*That*, The Presbytery of the Northwest Coast (Presbytery) move toward the dismissal of the congregation, the pastor and property of MPC to the Presbytery of the Northwest, of the Evangelical Covenant Order of the Presbyterian Church;

That, an Administrative Commission of the Presbytery be designated, with the responsibilities and powers as delineated below, to conduct a full administrative review, historical and current valuation of the tangible and intangible assets of congregation and the corporation used as "a tool for the accomplishment of the mission of Jesus Christ in the world"<sup>1</sup>, and make a recommendation to the Presbytery regarding 1) dismissing the congregation, 2) dissolving the PCUSA congregation 3) future use of all assets, including the property for mission, 4) compensation to the Presbytery for the future loss of use of those assets, and 5) the relationships of the Pastor; ensuring comprehensive due diligence on all ecclesiastical and constitutional matters so that if necessary, the parties can dissolve the current and historic covenant forthrightly, faithfully, and with good will.

### Historical Background

In a letter to COM dated July 9, 2014, the Session stated that it had "voted unanimously to enter into a period of congregational discernment with regard to our denominational affiliation."

MPC's session ("the Session") and a team designated by COM engaged in a lengthy process of discernment to "find and represent the will of Christ" regarding the Session's request. From the beginning of that process the Session expressed a desire to be dismissed on the grounds that the PCUSA, through a series of Constitutional decisions, has drifted from biblical principles, and that affiliation with the PCUSA hampers its mission. Likewise, the Presbytery has held that the Session has not developed a case which supports the *need* to be dismissed, while the Session has expressed the *desire* to be dismissed. Furthermore, the Presbytery has held that MPC has continually grown during the past decade, and has effectively accomplished its mission, and that the Session has not addressed the 1700 year old theological insight developed definitively in the Donatist controversy of 400's that the Church's purity is not based on the people who comprise it, but on the purity of its Lord and Head – Jesus Christ. The Presbytery has continued to affirm and support the diversity of the theological and biblical positions of its congregations, and has and would continue that affirmation and support of MPC's positions if the request for dismissal was withdrawn.

In a letter to COM dated October 14, 2015 the Session requested dismissal to ECO: The Evangelical Covenant Order of Presbyterians.2

### Principles and Rationale

Dissent is constitutionally protected; defiance is never protected. Governing bodies may surely dissent or protest actions of a higher body and may overture higher bodies for changes in policies or the Constitution itself. If an officer finds that his or her conscience permits him or her to neither concur or submit to the determination of the majority, he shall peaceably withdraw from our communion *without*

attempting to make any *schism*. The duty of the church is always to attempt to bring the estranged member back into the covenant community and to be open to hearing minority voices because we know in our tradition that those minority voices are sometimes the voice of God to us.

According to the Constitution,

"The relationship to the Presbyterian Church (U.S.A.) of a congregation can be severed only by constitutional action on the part of the presbytery (G-3.0303b). If there is a schism within the membership of a congregation and the presbytery is unable to effect a reconciliation or a division into separate congregations within the Presbyterian Church (U.S.A.), the presbytery shall determine if one of the factions is entitled to the property because it is identified by the presbytery as the true church within the Presbyterian Church (U.S.A.). This determination does not depend upon which faction received the majority vote within the congregation at the time of the schism."

Separate surveys administered by the Session and COM have attempted to gauge congregational alignment with the Session's position and/or support for PCUSA/Northwest Coast affiliation.

Throughout this process, a minority group of church members has expressed its objections to the Session's desire and process for dismissal. COM has maintained communication and has consulted with this group. While this minority may constitute "the true church," COM believes its continued existence, health and growth would be hampered by assuming the property currently "held by or for [this] congregation . . . in trust nevertheless for the use and benefit of the Presbyterian Church (U.S.A.)"

MPC has benefitted from a legacy of support from the PCUSA through and with the Presbytery from its establishment in 1907 and the change of location and expansion in this century. MPC has become what it is today on account of that support.

We enter this process of dismissal with a commitment to the spiritual and ecclesiastical well-being of MPC and NWCP, and to engage in this dismissal process as a demonstration and witness to the gospel of Jesus Christ who commanded us to interact with one another in truth and grace.

### The Administrative Commission

COM recommends to the Presbytery that an Administrative Commission be designated by the Presbytery to manage the dismissal of MPC, with the following responsibilities and powers, and to propose to the Presbytery for its approval, the terms for dismissal:

- 1. <u>Conduct a full Administrative Review</u> to examine all relevant records; obtaining professional services if needed to do so, fees for such services to be born by MPC.
  - a. Conduct a full financial *audit*, including verification of assets and liabilities by a CPA, ensuring that no assets are held by any other corporation than that of the church, held in trust for the Presbyterian Church, USA according to its constitution;
  - b. Assessment of values of real property, installations and equipment by one or more professional appraisers;
  - c. Legal review of all property titles, insurance, by-laws, charters, and corporate documents.
  - d. Review of bylaws, session minutes, any and all governing documents or records, newsletters,

website content, correspondence and any other communication or transmission, electronic or otherwise;

- 2. <u>Keep all parties informed, including members of the session and the congregation, of process, and progress.</u>
- 3. <u>Assume Original Jurisdiction</u>, dissolving the Session and assuming all of its responsibilities and powers, on approval of the Northwest Coast Executive Board, if ownership of assets have been transferred or moved to another corporation or individual, or ecclesiastical or corporate documents have been altered in such a way to avoid fair settlement; assets to be frozen.

### 4. Re: Pastor:

- a. If, in the course of investigation, it is determined that the Pastor actively engaged in schismatic activities in violation of vows (W-4.4003), the A.C. may file disciplinary charges.
- b. Actual dismissal of the pastor to be conducted by COM in consultation and conjunction with the dismissal agreement.
- 5. <u>Financial Compensation</u> Since the establishment of this congregation in 1907, the congregation and the Presbytery have been partners in ministry employing people, resources and assets provided by or supported by the Presbytery for the accomplishment of the mission of Jesus Christ. The Administrative Commission is instructed to value each of the following and frame an agreement that divides total value equally between the Presbytery and the dismissed congregation:
  - a. Financial support necessary for determining and sustaining the strategy for mission of the PCUSA/Northwest Coast Presbytery in Mukilteo, including pastoral leadership and a physical location for worship and ministry to the community;
  - b. The value in current dollars of any and all financial investments contributed by the Presbytery since the establishment of the congregation;
  - c. The value of the contributions those church members, past and present, loyal to the PCUSA and the Presbytery, who have contributed financially to the operation of MPC and its long term assets.
  - d. The value of all current assets and liabilities, including real property;
  - e. The loss of congregational contributions to the Presbytery, including per capita payments, mission support, and support of the Presbytery's Covenant Partners.
- 6. <u>Revisions</u> If, in the course of its "investigation," it becomes necessary or to revise these parameters, request the Presbytery's Executive Board to do so on behalf of the Presbytery.
- 7. <u>Name and Corporation</u> The Presbytery shall retain the name "Mukilteo Presbyterian Church," and the current corporation; the dismissed congregation shall cause a new corporation with a new name to be formed.
- 8. Determine and recommend the nature of any future relationship.
  - a. Determine what, if any, areas of joint ministry that may exist.
  - b. Define the future relationship.
  - c. Determine terms for reaffiliation.
- 9. Work with all due diligence and without delay, keeping costs fair and reasonable, and negotiating in good faith to bring a recommendation for settlement to a stated or called meeting of the presbytery for its approval.

The opening of the meeting was preceded by workshops on 1001 New Worshiping Communities, the proposed constitutional amendments, and the 2017 proposed presbytery budget. A service of worship followed the workshops at 5:00 p.m. during which host pastor Rev. Kwon preached the sermon and the Reverends Kurt Helmcke and Rebecca Anderson presided over the Lord's Supper. Dinner was served by the host church at 6:00 p.m.

A quorum was present.<sup>1</sup> The agenda and the minutes of the May 19, 2016 meeting were approved as distributed. Members of other presbyteries, formerly known as corresponding members, were recognized and greeted. Commissioners attending a presbytery meeting for the first time were introduced.

Mission and Ministry of Community Church of Seattle

Elder Kim of the host church presented a video and shared about Community Church of Seattle.

## **Stated Clerk's Report**

Coulee Dam Community Church dissolution – The Council of Central Washington Presbytery designated an Administrative Commission on November 20, 2015, to "oversee the closing of the Coulee Dam Community Church. At the May 19<sup>th</sup> meeting of the presbytery, the commission was "authorized to execute the final disposition of all property, equipment and assets, including the sale of real property." The commission has sold the property and concluded its work. The minutes of the commission are attached as actions of the presbytery<sup>2</sup>. The following resolution was APPROVED, That the Coulee Dam Community Church PC(USA) be dissolved, and that the commission be dismissed with thanks.

<u>Constitutional amendments</u> – The proposed amendments to the Constitution approved by the 222<sup>nd</sup> General Assembly and recommended to the presbyteries for their vote were placed before the presbytery as a series of resolutions offered by a single main motion. The moderator asked if there were requests to have any amendment in the series taken up and voted on separately. There were none. The presbytery APPROVED amendments 16-A through 16-H<sup>3</sup>.

<u>A Written Letter of Alleged Offense</u> was received by the Stated Clerk which has been referred to an Investigating Committee according to D-10.01023 of the Rules of Discipline and the bylaws.

<u>Tentative 2017 Leadership Summit Schedule</u> – Hybrid meetings Thursday, February 23, Thursday, June 8; Annual Leadership Summit October 20-21.

<u>Financial Reports</u> – The presbytery reviewed the Statements of Financial Position and Activity for the period ending August 31, 2016.<sup>4</sup>

## **Presbytery Executive**

Executive Presbyter Schlosser-Hall reported briefly on the recent spiritual pilgrimage to Korea. He presented Rev. Paul Kim and Rev. James Kwon gifts of appreciation and thanks for leading the trip.

#### **Executive Board**

Board Moderator Rev. Kurt Helmcke reported. The minutes of the regular meetings of December 19, 2015 and January 22, 2016 were distributed with the agenda. Rev. Helmcke recognized those serving on the Board who were present.

<u>Tidelands Charter</u> – The following resolution recommended by the Board was APPROVED as follows: *Resolved*, That, The Executive Board recommend to the presbytery that it receive the Tidelands organizing

covenant and "declare them an organized congregation of the presbytery. The congregation shall then proceed, with Brandon Bailey as moderator of the congregational meeting, to the election of ruling elders and, if they so decide, deacons" (G-1.0201);

That, The Administrative Commission designated below "prepare, examine, ordain and install these newly elected persons (G-1.0201);

That, The following Administrative Commission install Brandon Bailey as Pastor, if elected by the congregation: John Mason (Moderator), Jason Kreutz (Mountain View), Janice Smith (Acme), Paul Strawn (HR), Denise Easter.

Organizing Pastor Brandon Bailey was recognized by Moderator Kwon and the presbytery prayed for him, and the new congregation.

**2017 Budget & Five Year Plan<sup>5</sup>** – E.P. Schlosser-Hall and Board Moderator Helmcke offered a presentation on the budget proposed by the Board. The following resolution was APPROVED as follows: "*Resolved*, That 2017 budget and per capita be adopted, acknowledging that the 2018-2021 budgets in the attachment are pro forma forecasts only and will be revised as needed each year."

<u>Presbytery Mission Statement</u> – The Board recommended the following amendment to the bylaws [text to be deleted shown with a strike-through; text to be added is shown in italic].

Section 2.100, <u>Mission Statement</u>, – "To engage, equip and encourage Congregations as together they Serve Jesus Christ to transform the world; encouraging partnerships within and between our sub-regional groups of churches to develop a common bond and shared direction, nurturing those called to leadership and service training, support, renewal, and enrichment." Guided by the Triune God, the mission of the Northwest Coast Presbytery is: "To engage, equip and encourage congregations and their leaders, dispersed yet connected throughout the region, as together we faithfully serve Jesus Christ to transform the world."

The amendment was APPROVED.

<u>UNITE</u> Youth Retreat Grant Request – The following item was on the agenda for a special meeting called on October 24 where a quorum was not obtained. Background information was provided in the agenda. Because of the timing of the event and the request, Board Moderator Helmcke moved that a \$5,000 grant for the UNITE Winter Youth Retreat be awarded from from unrestricted/undesignated funds. After discussion the motion was APPROVED.

#### Executive Board Actions Reported to the Presbytery

<u>Mukilteo Administrative Commission</u> – The Board designated teaching elders Janet Sonnanburg and Paul Heins as additional members of the commission.

<u>Sitka Roof Replacement</u> – A grant of \$58,765.00 was made to the First Presbyterian Church of Sitka to replace the roof.

<u>United Presbyterian Church of Seattle Administrative Commission</u> – A letter dated June 6, 2016 was received from the session of the United Presbyterian Church of Seattle asking that the presbytery assume original jurisdiction of the session in the area of finance. A written letter of alleged offense dated July 2, 2016 was received by the Stated Clerk in regard to a ruling elder which also requested that the presbytery assume jurisdiction and power of the session to determine work disapproved for a ruling elder. The following resolution was APPROVED by the Executive Board on behalf of the presbytery:

Be it Resolved, That David Rood, Calvin PC; Randy Finson, Mountain View PC; Rev. Ted Schuldt; (Moderator) be designated as an Administrative Commission with the following responsibilities and powers in regard to the United Presbyterian Church of Seattle, a member congregation of the Presbytery of the Northwest Coast:

- 1) determine whether the church is "affected with disorder, and inquire into and settle difficulties therein [G-3.01 (b)(5)]... hearing all persons on matters at issue... When an administrative commission has been designated to settle differences within a particular organization or council, it shall, before making its decision final, afford to all persons affected by its decision fair notice and an opportunity to be heard on matters at issue." G-3.01 (b)(6) paragraph 7.
- 2) In the area of finance, conduct a Special Administrative Review (G-3.0108), requiring the session to produce any records the Commission desires, investigate to see if there have been any irregularities or delinquencies, and order the session to take any corrective actions that might be necessary. The Commission is authorized to use the services of a Certified Public Accountant, and if it elects to do so, the selected firm, service or individual should be reasonably agreeable and acceptable to all concerned parties.
- 3) Assume original jurisdiction of the session, as provided by G-3.03(e), and as requested by the session, in the area of church finances specifically delineated in G-3.0205, including but not limited to providing information to the congregation. Current day to day operations, procedures, and management of all financial transactions are to continue exactly as they presently are and have been; there should be no immediate changes in any process or personnel except by order of the Commission. The Commission will review operations, management and personnel and will recommend or order any needed corrections or improvements.
- 4) Keep a record of its proceedings, findings, orders, and decisions, to be included in the minutes of the presbytery and published accordingly. (G-3.01(b)(6) para. 3.
- 5) If, in the course of its investigation, the Commission discovers or has reason to believe that a person or persons in an ordered ministry (elder or deacon) or a church member, has committed an act or omission that is contrary to the Scriptures or the Constitution of the Presbyterian Church (U.S.A.), submit to the Stated Clerk of the Presbytery a written statement of alleged offense, with any supporting information, for investigation, judicial process, and censure if warranted, as provided by D-10.0100.
- 6) Assume the original jurisdiction of the session to determine whether a ruling elder or deacon has persisted in disapproved work as determined by the Administrative Commission as provided by G-2.0407: . . . When a ruling elder or deacon persists in work disapproved by the session [Commission], the session [Commission] shall consult with him or her and shall give notice of its disapproval. If, after having been provided opportunity for consultation and upon written notice of its disapproval, the ruling elder or deacon persists in the work, the session [Commission] may then conclude that the ruling elder or deacon has renounced the jurisdiction of this church. Renunciation of jurisdiction shall remove the ruling elder or deacon from membership and ordered ministry and shall terminate the exercise of the ministry."

Financial Review – A financial review for 2015 was completed by an independent CPA firm and is attached<sup>6</sup>

<u>Cash Management/Bellingham First</u> – The Board APPROVED a resolution to permit and guarantee Bellingham First to borrow up to \$250,000 in the form of a line of credit from Mission Development Certificates Northwest at 4% annually, and for the presbytery to invest \$50,000 for three years from the presbytery Wells Fargo Savings Account (currently \$891,051) in a Mission Development Certificate which allowed the church to

obtain a 1% lower interest rate.

<u>Grants</u> – A grant of \$4,370 was awarded to the INN, of FPC Bellingham, from the Synod Higher Education Fund; a Community Blessing Grant of \$10,000 was awarded to Tierra Nueva for its Emerging Leaders Program.

<u>Stated Clerk/Budget Manager</u> – The Stated Clerk's position was revised last year to include communicating the financial activity and position of the presbytery, and it has continued to grow. The Treasurer, E.P. and Finance Committee recommended, and the Board approved, designating Stated Clerk Dean Strong as "Budget Director," until and if the presbytery elects him to the office of Treasurer.

Terms of Call: Stated Clerk/Budget Director and/or Treasurer, .75 FTE for the presbytery, .25 FTE as Synod Stated Clerk (Synod to be billed for its prorated share of salary and benefits, 32.8%, based on salary); employment revised to clergy self employed serving a validated ministry of the church, including full Board of Pensions benefits:

Budget Director general duties, to be more fully described in a position description to be developed by Personnel Committee: Draft the annual budget, supervise bookkeeper making category adjustments as needed, approve the payment of and assign budget categories for all presbytery expenditures and allocations, assist the bookkeeper with and/or prepare the financial statements from Quickbooks software; provide timely financial data to the Executive Board and the Presbytery.

<u>Campbell Farm Deferred Maintenance and Planning Proposal</u> – The board has reviewed the history of Campbell Farm and its current situation. Board member Warren Weber visited the farm and provided a report with recommendations. The Board approved the recommendations and has employed Warren Weber (also a general contractor) to address the farm's current state, future possibilities, physical improvements and administration as delineated in a memo dated August 29, 2016 (see Board minutes), for \$41,500 in labor and up to \$60,000 for materials, for a total cost not to exceed \$101,500, contingent upon review and agreement of the Campbell Farm Advisor Board.

<u>Focus and Infrastructure</u> – The Board has been examining the future needs of the presbytery and appointed five task forces who examined and submitted recommendations in five areas: mission statement, facilities, technology, staffing, and Covenant Partners. The mission statement revision is above as an amendment to the bylaws. Facilities work is still in progress. Technology is working on conferencing communication and an integrated database. Staffing is in progress, see below. Covenant Partners has completed its work and the Board has adopted some of its recommendations and is consider others.

<u>Staffing Task Force</u> – The Board has reviewed a progress report, and has directed this task force to continue to developing details, including positions descriptions, prioritizing positions and their sequence, costs, and funding.

<u>Task Force on Covenant Partnerships</u> – A report has been received by the Board but has not been fully considered.

<u>Birchwood Property Sale</u> – A member of the congregation donated some vacant land to the church for unrestricted undesignated use. The session accepted the property and has obtained the congregation's permission at a congregational meeting held on September 4, 2016, to sell it for \$20,000, and place the net estimated proceeds of \$16,184.00 into the church's operating reserves. The Board, on behalf of the presbytery, granted permission for

the session to sell the property identified as 17016 Glacier Rim Drive, for \$20,000; this action constituting written permission as required by G-4.0206a of Part II of the Constitution of the Presbyterian Church (U.S.A.). A certificate of resolution containing the legal description are attached to these minutes.<sup>7</sup>

#### **Examinations and Introduction of New Members**

Exam Team Moderator Dennis Hughes was introduced by the moderator. The following candidates for presbytery membership were invited forward and were introduced by Rev. Hughes.

<u>Fenner Ordination/Mukilteo PC(USA)</u> – Mary Chatherine Jones Fenner, is a Candidate of Middle Tennesse Presbytery certified ready to receive a call. She has been employed by the Executive Board to serve as a reorganizing pastor for the members of Mukilteo Presbyterian Church who wish to remain as a congregation of the presbytery and the PC(USA), and her terms of call have been approved by the Commission on Ministry.

Candidate Fenner was examined by the Exam Team according to the presbytery's process, MMM 4.4201, reviewing her written responses, which were distributed to the presbytery, and orally examining her according to Christian faith and views in theology, the Bible, the Sacraments, and the government of the church. There were no items discovered during the oral examination that the Examination Team believed should be disclosed to the presbytery. The recommendation of the team was that she proceed to ordination and be received as a member.

The candidate addressed the presbytery and provided a brief statement of faith and commitment to the ministry of the Word and Sacrament. The presbytery examined her further on her Christian faith and views in theology, the Bible, the Sacraments, and the government of the church. A motion to end the examination was approved. After excusing the candidate, and after discussion, the presbytery APPROVED the recommendation, that Candidate Catherine Fenner proceed to ordination and installation as Organizing Pastor of the Mukilteo Presbyterian Church PC(USA). The Commission on Ministry will designate an administrative commission to conduct a service of ordination and installation.

<u>Taylor/Port Angeles</u> – The Rev Wendy Taylor is a member in good standing of Olympia Presbytery. She has been serving as the Interim Pastor of Port Angeles Presbyterian Church since September 1, 2016, as approved by the Commission on Ministry. Before beginning work, she was interviewed and recommended for membership by the Exam Team, according to the presbytery's process, MMM 4.4201, reviewing her written responses, which were distributed to the presbytery, and orally examining her according to Christian faith and views in theology, the Bible, the Sacraments, and the government of the church. There were no items discovered during the oral examination that the Examination Team believed should be disclosed to the presbytery.

Rev. Taylor offered a brief statement of faith and her commitment to the ministry of the Word and Sacrament. Members of the presbytery continued the examination until a motion to end the examination was approved. After discussion, the Team's recommendation that she be received as a member was APPROVED.

<u>Blankenship/Member-at-large</u> – The Rev. Jan Blankenship is a member in good standing of Northern New York Presbytery living in Juneau. She was interviewed and recommended for membership by the Exam Team, according to the presbytery's process, MMM 4.4201, reviewing her written responses, which were distributed to the presbytery, and orally examining her according to Christian faith and views in theology, the Bible, the Sacraments, and the government of the church. There were no items discovered during the oral examination that the Examination Team believed should be disclosed to the presbytery.

Rev. Blankenship offered a brief statement of faith and her commitment to the ministry of the Word and Sacrament. Members of the presbytery continued the examination until a motion to end the examination was approved. After discussion, the Team's recommendation that she be received as a member was APPROVED.

Commissioned Rule Elder Jan Smith welcomed the new members with fun, games, and "parting gifts." The retirement Rev. Tom Salmon was recognized. The presbytery gathered around these members, new and old, laid

hands on them, giving thanks and praying for them.

## **Commission on Ministry**

The following report was distributed with the agenda and was received and reviewed by the presbytery. There were no further questions regarding the reported actions of the commission.

## **Authorized Actions Reported to the Presbytery:**

<u>2017 COLA Recommendation for teaching elders</u> is 0.5%. This is the average between the CPI Jan-July 2016 increase of .8% and the anticipated Social Security COLA increase of 0.2% for 2017.

## COULEE DAM ADMINISTRATIVE COMMISSION December 14, 2015

The Commission held its first meeting at the home of Jerry and Susan Kennedy in Electric City on December 14, 2015. The meeting was convened with prayer by the AC Moderator TE Muriel Brown. In addition to the Moderator the following AC members were present: TE Becky Anderson, RE Steve Syre, and RE Jerry Kennedy, RE Mike Nixon (Presbytery Stated Clerk, ex officio without vote) and TE Kevin Nollette (Interim Presbytery Executive, ex officio without vote). Absent was RE Jim Irwin. Also present was RE Susan Kennedy, clerk of the Coulee Dam Session.

The Commission spent time in getting acquainted with each other and the duties assigned to the Commission. The Administrative Commission is authorized to:

- a. Assume original jurisdiction if the Session is unable to oversee the ongoing life of the Coulee Dam Church before the effective date of the closure;
- b. Work with the session in helping members to transfer their membership to other churches;
- c. Develop a plan for providing pastoral care for those whose membership has not been transferred by the date of dissolution;
- d. Make declaration to the congregation and others according to need that the property and other assets of the church belong to the Presbyterian Church (USA) and that the Presbytery will hold them in trust when the congregation is dissolved. The committee will ensure that all titles of property, beneficiaries of trusts and endowments are changed over to the Presbytery, and that all accounts payable and receivable will be changed to the name of Presbytery;
- e. Consult with the session regarding the disposal of equipment, memorials, etc.
- f. Consult with the session regarding which records of the Session are to be turned over to the Presbytery at the time of dissolution;
- g. Take necessary steps to dissolve the corporation in accord with the laws of the State of Washington;
- h. Ensure that all liabilities, including financial obligations, are satisfied from the assets of the Coulee Dam Community Church prior to its dissolution;
- i. Make a final report to the Presbytery along with enabling motions to close all matters related to the Coulee Dam Community Church.

Upon motion by Steve Syre, the Administrative Commission VOTED to assume original jurisdiction with full powers of the Session on January 1, 2016.

Jerry Kennedy agreed to continue on as Treasurer. There was general discussion regarding the need to secure the building, changing locks, seeing about roof repair, doing a title search, providing pastoral care to remaining members, etc. Susan Kennedy will see that there is a monthly Bible study/prayer meeting held in the church building so that the property will still qualify for tax exempt status as used for "religious purposes."

The Administrative Commission ended with prayer at 5:30 p.m. as we were joined by members of the Session for a light supper, which was followed by their Session meeting.

### January 20, 2016

The Coulee Dam Administrative Commission met via conference telephone call on January 20, 2016. The Moderator, TE Muriel Brown, opened the meeting with prayer at 10:05 a.m. Present in addition to the Moderator were RE Jerry Kennedy, RE Steve Syre, and Stated Clerk RE Mike Nixon (ex officio without vote). Absent were TE Becky Anderson and RE Jim Irwin and Interim Presbytery Executive TE Kevin Nollette (ex officio without vote).

The purpose of the meeting was to deal with some issues that Jerry had raised in a memo that accompanied his year-end financial report.

Regarding an audit of the church books, it was decided that yes there should be an audit/financial review. It was decided that Mike would contact Lynda Mikkelsen about doing this work for us. And that she and Jerry together would decide the number of years to review.

The Commission VOTED to name Steve Syre as an additional signatory on the checking account, but still requiring only one signer. The Commission decided that there was no good reason at this time to transfer some (or all) of the funds to the Presbytery for disbursement while the presbytery merger process is going on. Steve raised the possibility of Jerry receiving some remuneration for his work as treasurer, but Jerry refused to consider that.

It was decided that the Per Capita Invoice for NW Coast Presbytery for \$1429.50 should be paid in full, seeing no reason to request a lesser amount.

The fellowship hall roof was leaking again. Bob Hendrickson, a local man with a Handyman business that is a licensed contractor, has been asked to check that out. He might be called on for additional problems that develop. Jerry was authorized to make arrangements as necessary for the roof and possible sidewalk snow removal.

The estimate from the locksmith for changing all the outside door locks came in at \$100, so Jerry has made those arrangements. It was decided that extra keys would be available (for pick up and return) at Jerry's office (Foisy Kennedy, on the main drag coming through Grand Coulee-across from Safeway) for commission members and others who may need to get into the church building at some point.

Jerry offered his phone number for CenturyLink's referral intercept service. This will cut down considerably on phone bills, but still allow for knowing in timely fashion about possible pastoral care needs and persons who may be interested in the building.

The Commission decided to keep the dumpster until the end of February as Susan Kennedy and a preschool teacher are still cleaning out stuff.

There have been a couple of inquiries about the building, including one from the pastor at the Almira Community Church, which draws people from a rather large surrounding area, and might want to consider a satellite site at the Dam. Jerry had to leave the phone call at 11:00, so Mike will check with him to see if he has requested a title report yet.

Mike and Muriel talked some about membership issues and whether there is some kind of letter that should go to the remaining members to explain in writing about their membership being held by the presbytery and whom to contact when they have decided on a new church home, etc.

The conference phone call ended at 11:30 a.m.

The Coulee Dam Administrative Commission met in the conference room at the Coulee Dam Community Church on February 15, 2016. The Moderator, TE Muriel Brown, opened the meeting with prayer at 1:05 p.m. Present in addition to the Moderator were RE Jerry Kennedy, RE Steve Syre, RE Jim Irwin and Stated Clerk RE Mike Nixon (ex officio without vote). Absent were TE Becky Anderson and Interim Presbytery Executive TE Kevin Nollette (ex officio without vote). Also present were RE Susan Kennedy, former Clerk of Session for the Coulee Dam Church and Pastor Paul McArthur of the Almira Community Church and two of the leaders in the Almira congregation, Mel Stone and Jeff Cochran.

The purpose of the meeting was to hear from the Almira folk their vision for using the Coulee Dam property as a second campus or site in their ministry and outreach. Their congregation currently has 100 or more worshippers on a Sunday morning, drawing from a rather large area including some from the Coulee Dam area. Pastor Paul shared about his having written his Master's Degree thesis on the rural church at multiple sites and thus his immediate interest in the Coulee Dam building when he heard that it was going to be available. He had already shared his vision with the Almira Church Council, but not yet with the entire congregation.

The Administrative Commission was impressed with the earnest desire of the Almira folk to share the good news of Jesus Christ in the Coulee Dam area and on the Colville Reservation as well as their willingness to continue the long history of making the church building available to the community.

It was decided that the Almira folk would talk with their congregation about this possibility and continue to discern whether God was leading them to embark on this new venture. And then in a month or so the Administrative Commission would meet with them again and we would decide together whether to continue these conversations.

In another matter, the Administrative Commission VOTED to give permission/authority to Jerry and Susan Kennedy to make decisions about requests for use of the Coulee Dam building for memorial services, etc. as they thought best rather than having to seek the permission of the AC.

Pastor Paul McArthur offered prayer as the meeting adjourned at 3:00.

#### March 31, 2016

The Coulee Dam Administrative Commission met in the conference room at the Coulee Dam Community Church on March 31, 2016. The Moderator, TE Muriel Brown, opened the meeting with prayer at 10:00 a.m. Present in addition to the Moderator were RE Jerry Kennedy, RE Steve Syre, RE Jim Irwin and TE Becky Anderson. Absent were Stated Clerk RE Mike Nixon (ex officio without vote) and Interim Presbytery Executive TE Kevin Nollette (ex officio without vote). Also present were RE Susan Kennedy, former Clerk of Session for the Coulee Dam Church, and Pastor Paul McArthur, Mel Stone and Jeff Cochran of the Almira Community Church.

The folk from Almira reported on their conversations with the members of the Almira Community Church, which seemed very positive regarding the possibilities for opening a second campus/site and worshipping community for their congregation in Coulee Dam. The only comments that could possibly be construed as negative in any way had come in the form of questions about how this would fit with their plan to enlarge their current building's fellowship area, kitchen and restrooms. When asked specifically about how their members who live in the Coulee Dam area responded, the indication was that the response was overwhelmingly positive, some even with tears in their eyes.

Discussion followed on issues of lease agreement vs. sale/transfer and on deferred maintenance projects, particularly the need for a new roof and which party would pay for what, etc. Mel Stone said that he knew a roofer whom he trusted implicitly from whom he thought we would get a very reasonable bid and he agreed to get an estimate from him. The Almira folk (mostly farmers) could offer trucks, etc. The AC felt that we should be responsible for as much of the cost of the roof as our funds would allow.

The Almira folk were dismissed and the Administrative Commission continued with other business.

The renewal date for the current insurance policy is coming soon and Muriel was asked to contact Corey Schlosser-Hall to see if he had contacted the company that handles Northwest Coast Presbytery's insurance. If that cost would not be cheaper we would continue with the current policy, paying on a month-to-month basis.

On motion by Jerry, the Administrative Commissioned VOTED the following to be communicated to the Almira Community Church: That we convey the real property to them, with the only consideration being a requirement that they operate a church there for at least 10 years. The deed would have a clause providing that ownership revert to the denomination if they did not. Further that we would provide much of the remaining cash assets of the church to help with cost of replacing the roof, the exact amount to depend on the amount of assets remaining and the cost to replace the roof.

The meeting was adjourned at noon with prayer by Becky.

The Moderator noted for the record that the Presbytery of the Northwest Coast, at its meeting on May 19, 2016, at Kennewick, had taken the following action: "that the Coulee Dam Community Church Closure Administrative Commission be authorized to execute the final disposition of all property, equipment and assets, including the sale of real property." Stated Clerk Mike Nixon forwarded to the AC the draft minutes of the Presbytery meeting showing the above action.

The Administrative Commission VOTED to reaffirm its action of March 31, 2016, that the AC is gifting the building to the Almira Community Church and that in addition we estimate that we will be able to pay at least \$65,000 toward the expenses of the roofing project. Muriel will communicate this to the Almira congregation.

The Administrative Commission VOTED to authorize Jerry Kennedy to work with the attorney (Scott Yasui with Riddell Williams in Seattle) regarding the necessary legal paperwork and that Jerry also be authorized to sign the closing documents on behalf of the Administrative Commission.

Stated Clerk Mike Nixon reminded the AC that the official records of the Coulee Dam Church during its Presbyterian years will need to be preserved and sent to the Presbyterian Historical Society.

There being no further business, the meeting was adjourned at 10:00 a.m. Mike Nixon offered prayer.

The Coulee Dam Administrative Commission met by conference telephone call on September 7, 2016 at 9:00 a.m. The Moderator, TE Muriel Brown, opened the meeting with prayer. In addition to the Moderator the following AC members were present: RE Jerry Kennedy, RE Jim Irwin, RE Steve Syre, and TE Becky Anderson.

Treasurer Jerry Kennedy reported that he had paid the final utility bill and that there was more than \$72,000 left in the checking account. The Administrative Commission VOTED to give \$69,217 to the Almira Community Church, which was the amount of the estimate for the roof repair which they had received. The Administrative Commission also VOTED to authorize Jerry Kennedy to close the checking account when he was certain that all bills had been paid and send any remaining balance to the Northwest Coast Presbytery to be used as they see fit.

Jerry Kennedy reported that Lynda Mikkelsen, Eastern Washington Business Services, had on June 15 reviewed the financial records of the church for December 31, 2010 through June 15, 2016. Her "findings are that all accounts have been handled accurately."

The Administrative Commission reviewed the tasks we had been assigned and authorized to accomplish. We directed Jerry Kennedy to follow through on closing the L & I account and to do what is necessary to dissolve the corporation.

The Administrative Commission VOTED to recommend to the Northwest Coast Presbytery that the congregation of the Coulee Dam Community Church PCUSA be dissolved and that the Administrative Commission be dismissed.

The meeting was adjourned with prayer by TE Becky Anderson at 9:40 a.m.

  - 16-C.3. On Amending G-2.0301
  - 16-C.4. On Amending G-2.05 and G-2.0501

  - 16-C.8. On Amending W-4.4001a.
- 16-D. <u>Relationship to the PC(USA) of a Person Who Has Renounced Jurisdiction of the Church.</u> *Addresses situations where clergy have renounced to avoid disciplinary action.* 
  - 16-D.1. On Amending G-2.0509: *Allows a teaching elder who renounced to possible perform work if he or she rejoins the church and resubmits to the disciplinary process.*
  - 16-D.2. On Amending D-10.0401: If an accused elder had renounced to avoid discipline, then later sought to return under 16-D.1 above, he or she would still have to face the original accusation with no statute of limitations.
- <u>16-E. Certified Service Requirements</u> On Amending G-2.1101 Removes antiquated language; Certification requirements for certain positions would be administered by a body approved by GA instead of "in a handbook provided by" such a body.
- <u>16-F. The Ministry of Members</u> On Amending G-1.0304. *Adds the phrase "caring for God's creation," to the list of criteria that describes the commitment and participation of church membership.*
- 16-G. Access to the Lord's Table On Amending W-2.4011a. and b. Paragraph "a" removes the phrase "invitation to the Lord's Supper is extended to all who have been baptized," allowing for an invitation to be given to all. Paragraph "b" requires the session to welcome and instruct children who are not participating in the Lord's Supper who express a desire to do so. These paragraphs are already included in the proposed revised Directory of Worship.
- <u>16-H. Revised Directory for Worship</u> On Replacing the Directory for Worship shorter, more streamlined and more permission-giving [and] less formulaic, but maintains the integrity of Reformed worship and the Constitution; the revisions was guided by seven principles:
  - Tuphold essentials of Reformed faith, life and worship.
  - P Respond to changing contexts and congregations.
  - Provide for more flexibility and more diverse expressions.
  - \$\textsquare\text{Use "we" language (vs. "they") for the people of God.
  - The Streamline contents and make it more user-friendly.
  - † Simplify language and rewrite the document in more accessible style.
  - † Eliminate redundancy and reduce length.
  - P Enhance the directory's usefulness as a teaching document.

## 2017-2021 Ministry Plan & Budget

Budget "subschedules" referenced herein are found on the budget worksheet.

NWC Presbytery is reformed and always reforming! See the transformation snapshot (Appendix 0) for a picture of how significant the last decade has been. 2017 is a new day. The willingness of all people across our expansive presbytery to embrace renewed life, together with the people, prayer, and financial resources God has given us, make it possible to launch a trajectory of ongoing transformation. This plan and budget proposes that we pursue this God-given opportunity. It is the most confident, hopeful plan we have pursued in recent history. And it's evolving!

To engage, equip and encourage our congregations and spiritual leaders is our prime directive. Every agency and person in our presbytery is directed toward that end. This plan attempts to show where we sense God may be calling us to **Extend and Improve** (section 1), Pathmaking (section 2), and Bolster Capacity for Ministry (section 3).

The overwhelming support NWC Presbyterians expressed for the **3 initiatives for investment** proposed by the Executive Board in April-June 2016 is embedded in this framework. The **3 initiatives for investment** we identified were: 1) Renewal of existing congregations open to renewal (aka "Congregational Renewal"); 2) Village Ministries; and 3) New Expressions of the Church (aka "New Expressions"). You will see these **3 initiatives for investment** reflected in the budget and following framework. However, this plan is not limited only to those initiatives.

These **3 initiatives for investment** will be highlighted in **RED** throughout the document to symbolize **Holy Spirit** fire and focus.

## 1) Extend and Improve (Appendix 1)

**A)** Congregational Renewal/Revitalization (Appendix 1A & Subschedule 4): Most of our congregations are healthy, doing well, taking next steps, developing in a Spirit-directed path. We will continue to invest our energy, intelligence, imagination and love in helping our congregations become all God is calling them to be through our COM, CPM, grants team, other committees and staff [subschedules 9-10]. Sometimes congregations realize they need and are open to a kind of renewal that is deeper and more significant than the ongoing work of healthy development. We're calling that "renewal" or "revitalization." Some call it "congregational transformation."

We are blessed with several congregations of all shapes, sizes and communities who have experienced renewal. And we have engaged and learned from many approaches to renewal in recent years. We will continue to extend and improve our learning through trial and error and trying again! This ministry is to be championed primarily by our Commission on Ministry (COM) because renewal is so dependent on effective spiritual leadership in congregations.

**B)** Village Ministries (Appendix 1B & Subschedule 5): Healthy village churches and spiritual leaders are core to our life together (13 congregations in villages of 1000 people or less). We are proposing to invest in Rural & Village Ministries through a new staff position who will address the unique circumstances of pastoral and session leader-

ship in villages, building a recruiting network, and assertively inviting mission giving from congregations in NWC Presbytery and around the country to these congregations.

**C)** Multi-cultural Integration (Appendix 1C & Subschedule 6): Since the 1800's Presbyterian ministry in our region has included ministry between indigenous peoples and immigrants. Native ministries has always been part of our identity that we want to celebrate and grow. This emphasis will be served significantly through the "Village Ministries" initiative because 5 of our 13 villages are planted in native villages.

Korean-American congregations (see more info in Appendix 1C) in neighboring presbyteries have requested to be part of our life together through fellowship and education. And we are working openly with the presbyteries where they currently participate to explore how we can extend these blessings to others. We want to expand Rev. Jinsuk Kim's Associate EP role to work with these congregations in neighbor presbyteries.

Recently, several families from Pakistan who speak Urdu have joined Mountain View PC in Marysville. Many of our congregations are in communities of majority Hispanic/Latino population and several host Hispanic ministries and other multicultural ministries. In the next 5 years we wish to extend and improve our multicultural integration!

## 2) Pathmaking, Innovation, Research & Development (Appendix 2)

Renewing the ministry of Jesus Christ through the Presbyterian Church (USA) requires persistent experimenting with how God wishes to send the church into the world. That means researching and developing new ways to engage the Gospel in God's world. Since 2009 we have helped 11 new expressions of the church get started. 7 of them continue. It's time to build a system that will support this movement over the next 10-years and beyond.

- **A)** New Expressions of the Church in NWC Presbytery (Appendix 2A & Subschedule 7): We expect one new church expression starting every year over the next 5 years. We intend to support each of them at approximately \$150,000 over 3-5 years depending upon the particular new church's mission plan. That is the level of support we have done for Tidelands and others and is a common level of support for new church expressions along the West Coast (Appendix 2A).
- B) New Expressions—"Cyclical" (Subschedule 7): We need an ongoing way to engage, equip, and encourage new expressions of the church for systematically over time, not only case-by-case. Toward that end we are proposing "Cyclical" as an ongoing ministry to invite potential pioneer leaders to discern and start new expressions of the church. "Cyclical" has been effectively ministering ecumenically in the Los Angeles area (<a href="www.cyclicalla.org">www.cyclicalla.org</a>) in partnership with San Fernando Presbytery. It is led by Nick Warnes, a new church pastor and effective consultant. They are willing to work with us to begin a similar ministry in the Pacific NW.

Our 1001 New Worshipping Communities staff and resources from the Presbyterian Mission Agency are willing to work with us to make this happen. And we intend to collaborate with Seattle and Olympia Presbyteries and potentially, Westminster

Presbytery of the Presbyterian Church of Canada in British Columbia, along with regional ecumenical partners.

The rollout might begin with a "Cyclical" cohort in the King-Snohomish-Skagit County area. Then begin in either Tri-Cities area or Whatcom County/B.C. depending on who develops readiness first.

We propose that the "Cyclical" cohorts initiative be funded in partnership with grants from the Murdock Charitable Trust and Presbyterian Mission Agency, PC(USA). We are also proposing that this initiative begin with the goal of being self-funding and sustaining in 5 years just like we would expect from a new expression of the church.

## 3) Bolster Ministry Capacity (Support Services) (Appendix 3 & Subschedules 9-10)

The only way to weather so much change and advance our mission is to invest in more robust capacity for engaging, equipping, and encouraging our congregations and leaders for ministry. We will deepen that focus as the heart of what we do and keep getting better at it! The core currency of this ministry capacity is TRUST & LOVE.

For longer than 10 years we have sought to build trust and love of our fellowship together in every action and interaction. We believe this is "the juice" for why we are in this position to build and grow Christ's ministry more effectively over the next 5 years. We sure have missed the boat in many places, but we endeavor to be people who are safe and trustworthy for each other and for God's world!

Now that NWC Presbytery has grown to 55 congregations, 6 new expressions across 3 former presbyteries we must operate differently. We can no longer expect our EP to be the primary interpersonal connection with our congregations and pastoral leaders. AND we must continue to build trust and love in every interaction. Bonds of trust and love are personal. These *organizational* bonds are built through significant *personal* connections. A central approach to building ministry capacity is to prepare, bless, and deploy some additional staff and volunteers whose top priority is to build and deepen relationships of trust and love while enacting particular initiatives or functions.

- A. Staffing (Appendix 3A & Subschedules 4-7, 10): The 5-year plan proposes to maintain our current staffing, add some new staff for village ministries, congregational renewal, new expressions of church, and communications. It emphasizes staff who can make our ministry even more effective by building trust and expanding our use of technology. The Executive Board and their personnel committee/workgroup continues to work on the staffing plan and will provide updates as they continue that work.
- **B.** Additional Ministry Capacity (Appendix 3B & Subschedules 9-10): In addition to people, more ministry capacity is comprised of focused, competent presbytery agencies (COM, NOM, CPM, Exec Board); Means of connection and governance (Leadership Summits, regional gatherings, etc.); Financial Resources; Facilities; Technology; along with a streamlined, updated policy and guideline infrastructure.

## 4) Mission Beyond NWC Presbytery (Subschedule 8)

This section is more of a projection of congregational giving to our covenant partners and other mission beyond NWCP than a "budget." However, we think it's important to share & celebrate how generous you are in supporting our mission partners and others beyond NWC Presbytery.

The financial report doesn't tell the full story. For example, in 2015 (before the NWC/CW merger) congregations in NWCP gave about \$75,000 to Presbyterian Mission Agency (PMA) *through the presbytery*. These are the funds identified in our financial reports. However, several congregations also gave *directly* to PMA rather than through the presbytery. So in 2015, PMA actually received \$150,000 from NWC Presbyterians, about ½ through the presbytery and the other half directly. We expect that to continue!

In 2017 we are proposing to fund the former CWP mission partners (Tall Timber, Campbell Farm, Mending Wings, and Trailseekers) at the same level as in 2016. The Exec Board also working on an assertive, strategic investment in Campbell Farm to renew that ministry. Stay tuned!

The Executive Board has also formed a task force to consider our "Covenant Partner" criteria and who we will continue with as a covenant partner in 2017. That task force is completing its work and the Executive Board intends to act on their recommendations in December. More to come after that!

## Wrap-Up and Send Off

What will we look like in 2022? Given the last 10 years, it is hard to know.

Imagine our cohort of teaching elders continues to transform to include a much better balance of women, people of color, & pastors under 50. Imagine 10 of our existing congregations experiencing God's, life-giving renewal and the contagion of those experiences and stories. Imagine our 13 village ministries thriving with pastoral leadership, a well-developed "farm-system" or network for new village ministry leaders, and hope in the next chapter of life!

Imagine a much more "mixed-economy" of church expressions and leadership. Imagine existing congregations and leaders in symbiotic/synergistic relationship with new expressions of Christ's church and leaders. Imagine that through this interaction, all of us following the leadership of our triune God, we experience a great adventure, coursing Holy Spirit-energy, hope in the present and future, and God's transformation of our communities through shaping disciples of Jesus Christ who in turn shape a better world!

We expect the transformation we have experienced over the last 10 years has momentum that can be deepened. We pray our existing congregations and leaders flourish and are healthier than they have ever been. We anticipate that each of our village ministries will develop identities who are whole, focused on Christ's call, and abundant rather than infused with depression or worry about what they lack.

And we hope we are telling and sharing lots of stories about the curious, hopeful mission God is doing through the Northwest Coast Presbytery--YOU!

Scriptural Inspiration: New Testament Letters of Paul, Peter, and John to the Churches


Congregations are the foundation of NWC Presbytery. Healthy, thriving congregations means a healthy, thriving Presbytery. Healthy Leadership...pastoral and elder leadership together...is the linchpin to congregational flourishing. All the other factors of health in a congregation relate to, start with, or are enabled by leadership.

We can provide the best possible opportunities for spiritual growth and development. Encourage whole-hearted leadership and whole life stewardship. Share the best possible models and ideas for congregational renewal and development.

In a congregation that has become self-sustaining in its life-cycle...most of what is needed for healthy, flourishing congregations is NOT something money can buy. It's mature, flourishing, abundant-life people exercising Jesus-infused team leadership. That is a process of formation and development that we can nurture an expectation and habitat for, we can consult and coach for, we can mediate and teach toward, but we cannot *buy* it.

What we can invest in is—1) coaching and development of pastoral leaders to grow in their followership of Christ and wholehearted leadership: By wholehearted I mean courageous, compassionate, connected, and generous. 2) We can promote and invest in coaching, consultation and development of sessions to assess their congregation's health, stage in life-cycle, and identify actions that can help them move toward greater flourishing. But *they* have to do it. It can't be done *for* or *to*; it must be done *with*.

We should be cognizant that every congregation is at a different place on the spectrum of willingness to learn and grow. Only those congregations or leaders in the 4-5 range will be worth engaging. The others we will need to wait until either 1) they find leaders who build their willingness to learn; 2) the pain of staying the same becomes too much to bear; or 3) they have to face into a crisis, and they become willing to learn and grow:



## **APPENDIX 1(B)**

## Village Ministries & Sustainability

Scriptural Inspiration: Acts of the Apostles...establishing and nurturing a community of Christ in each locale. The combo of churches strengthen and encourage each together.

The new NWC Presbytery has 13 congregations or fellowships in villages (1000 people or less in the village/township). This provides a remarkable context for ministry in which these congregations are, or can become, indispensible to the health and well-being of their community and the kingdom of God!

NWC Presbytery needs a thoughtful, careful and effective approach to engaging, equipping, and encouraging village ministries in their context that meets at least four challenges.

Challenge #1: Recruiting, onboarding, and sustaining the most called and suitable pastoral leadership that fit that particular village context. Not only the most *available* candidates. And be flexible with the ecclesiastical pathways to call/send those people into the village context (Pastor, Tentmaker, CRE, Evangelist, maybe others). This means expanding our recruiting pool to first call candidates, seminary intern and residents, and others. We should have a robust, "next person up," posture. Pastoral transitions in villages should not be so long and difficult as they are now. This will include incentives like educational debt assistance for people fresh out of seminary, transitional salary support, and \$ for building community ministries.

Challenge #2: Provides financial support in a dynamic way that is built on self-reliance, self-determination, and self-propogation and does not foster the kind of dependency on "other people's money" that we've seen in the past. But one that recognizes the contextual limitations of funding for ministry in a village.

Challenge #3: A proposal that is sustainable and renewable financially and is interdependent with several funding sources--organizational and individual-from outside the congregation itself. Build broad-base of support from living givers and legacy givers rather than only 1 or 2 sources.

Challenge #4: An approach that identifies many paths by which a village church can sustain and thrive in ministry. Active learning and adaptation. Especially those ways in which robust partnering between congregations can lead to flourishing like the relationship between Acme PC and FPC Bellingham or the developing partnership between Northern Light United PC and Yakutat.

In short it meets the challenges of being a flourishing Body of Christ today and for the future. Not one built on the ways of the past that served well in the past, but now need to adapt.

## **APPENDIX 1(C)**

# Multi-Cultural Integration: Korean-American Congregations

Over the last 6-8 years we have intentionally sought to integrate our Korean-American sisters and brothers in our mission (8 congregations, 30% of our members)! Because of those investments we have been blessed with Rev. Jinsuk Kim, our Associate EP for Korean Ministry, Rev. James Kwon our first Korean-American, Moderator, elder Younghee Kim—our amazing interpreter, and Korean-Americans serving on every commission and committee in the presbytery. We hope our Korean-American brothers and sisters experience NWC Presbytery as their presbytery now more than ever!

This ministry is being noticed. Korean-American congregations in neighboring presbyteries have requested to be part of our life together through fellowship and education. And we are working openly with the presbyteries where they currently participate to explore how we can extend these blessings to others.

There are 7 Korean-American congregations in the other presbyteries of our synod: 2 in Seattle Presbytery; 2 in Olympia Presbytery; 2 in Yukon Presbytery; and 1 in Inland NW Presbytery. They are gathering for the Synod of Alaska NW annual KPC retreat in Leavenworth September 26-28. And we are inviting the pastors and elders from these churches to join us for our fall leadership summit November 4-5 to experience the worship, fellowship, and education of NWC Presbytery.

## **APPENDIX 2(A)**

## New Expressions of the Church: R&D/Innovation

Scriptural Inspiration: Acts of the Apostles

New churches and new expressions of Christ's church is an area that we can invest in and build for. And it is essential for our Presbytery's mission, health and flourishing for at least 3 reasons: 1) It is the *best, proven* way for reaching people who we would describe as NONES or DONES and are not involved in Christ's church. There's no question that existing churches are mostly populated by people who are already Christian moving from other Christian churches. New Expressions of church are 2-3 times more likely to grow by including people who are NEW to Christian faith or were DONE with church and want to give it another chance.

- 2) New expressions of the church are the best way to increase the community leadership base across NWC Presbytery. All of our communities from Yakima to Yakutat need people connected to the Source of Life to help their communities flourish. Most non-profit ministries are not modeled on whole life discipleship nor are they as self-sustaining as a congregation. Yet we need those kinds of non-profit ministries to build community health. Congregations are the best source of people, abilities, and generosity to support other NGOs. So if we build flourishing congregations in each of our communities we are also building a foundation for whole community health! Want to see a community's leadership base just worship with Acme PC or Northern Light UC in Juneau, or Quilcene PC. It's remarkable.
- 3) New expressions of church are the best way to renew existing congregations. Why? Existing congregations who are further along the life-cycle have ways of being church they are reluctant to shift. New expressions of church have much more permission to innovate new ways of being church. As existing congregations and new expressions of church relate to each other they mutually encourage and renew each other. The permission to innovate and experiment in new expressions of church give existing congregations a lab to observe how new things work. The ways that lead to longevity and sustainability of existing congregations help new expressions learn how to sustain their innovations until today's innovation becomes tomorrow's need for renewal. The relationship between Mountain View PC and Tidelands Church is a good example of this synergistic blessing.


## **Appendix 3(B): Additional Ministry Capacity**

- 1. **Presbytery Agencies:** The budget fully funds the Executive Board, COM, CPM and related agencies of the presbytery so that these teams of volunteer leaders and staff can effectively perform their ministries and improve their service to our congregations and pastoral leaders!
- 2. **Leadership Summits and Regional Connections:** Stabilize our Leadership Summit schedule to 1 in-person leadership summit each October including VERGE 2.0 conference. And 2-hybrid leadership summits: One in February and one in April-May. Plan for a return to Alaska for a leadership summit in 2020.
  - And plan for 2 regional group gatherings annually during an afternoon or evening to fellowship and engage with each other around specific ministry topics in each of the following regions: SE Alaska, Central WA, Olympic Peninsula, Whatcom/Skagit/Island Counties, Snohomish/King Counties.
- **3. Financial Resource Development:** We cannot operate our new presbytery on per capita alone. We need to continue to expand giving and financial resources as our mission and ministry grow more effective and far-reaching. This will include individual giving, foundation grants and support, using presbytery reserves. We are so grateful God has sought to bless this presbytery with significant financial resources. We will be good stewards of this blessing!
- 4. **Policy Infrastructure:** Reform and complete Manual of Administrative Operations (formerly called Manual of Mission and Ministry) in 2017 consolidating best practices of all former presbyteries and best current approaches for policies and guidelines.
- 5. **Other** infrastructure advancements are currently being considered by work groups of the Executive Board. Recommendations will be brought to September 29, 2016 Executive Board meeting and updated in this document and budget.

## Note 1 - Nature of Activities and Summary of Significant Accounting Policies

#### **Nature of Activities**

Presbytery of the Northwest Coast is located in northwest Washington State and southeast Alaska with offices in Everett, Washington and is organized for the purposes of carrying on the affairs and ministries of a regional Presbytery body. The Presbytery was originally incorporated as a not for profit religious corporation under the laws of the State of Washington in July 1911 as Presbytery of Bellingham, which later became the Presbytery of the North Puget Sound, then in 2014 became Presbytery of the Northwest Coast.

In January 2015, the Presbytery of Alaska merged its operations with this Presbytery. In January 2016, the Central Washington Presbytery merged it's operations as well. See Subsequent Events Note 12 for details.

#### **Basis of Accounting**

The Presbytery presents financial statements in accordance with accounting principles generally accepted in the United States of America. This basis of accounting involves the application of accrual accounting; consequently, revenues and gains are recognized when earned, and expenses and losses are recognized when incurred.

# **Basis of Presentation**

The Presbytery is required to report information regarding its financial position and activities according to three classes of net assets: unrestricted net assets, temporarily restricted net assets, and permanently restricted net assets.

Unrestricted net assets - Net assets that are not subject to donor-imposed stipulations.

<u>Temporarily restricted net assets</u> - Net assets subject to donor-imposed stipulations that may or will be met either by actions of the Presbytery and/or the passage of time.

<u>Permanently restricted net assets</u> - Permanently restricted net assets must be maintained by the Presbytery in perpetuity, the income of which is expendable for operations. Permanently restricted net assets increase when the Presbytery receives contributions for which donor-imposed restrictions limiting the Presbytery's use of an asset for its economic benefits neither expire with the passage of time nor can be removed by the Presbytery meeting certain requirements. The Presbytery had \$576,137 of permanently restricted net assets at December 31, 2015.

### **Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates. Significant estimates include allowance for losses on uncollectable per capita receivables, useful lives of property and equipment, allocation of expenses to programs, original cost of real property, and current portion of long term debt.

#### Cash

For purposes of the statements of cash flows, cash includes time deposits, certificates of deposit,

and all highly liquid debt instruments with original maturities of three months or less which are not restricted by the donor for long-term purposes.

# **Buildings, Equipment, Improvements, and Depreciation**

Buildings, equipment, and improvements purchases are stated at cost. Donated assets are stated at fair market value at date of receipt. Donated services that enhance non-financial assets are capitalized at fair market value at the date the services are provided. Depreciation is provided by use of the straight line method over the estimated useful lives of the related assets ranging from five to ten years for equipment and twenty to forty years for buildings and improvements. Leasehold improvements are depreciated over the shorter of the noncancelable lease term or their estimated useful lives. The original cost of land and buildings purchased prior to 2015 was estimated using the original purchase dates, the current county assessed value, and the published inflation rate since the purchase date to calculate the net present value of the original purchase. All acquisitions of property and equipment in excess of \$1,000 and all expenditures for repairs, maintenance, renewals, and betterments that materially prolong the useful lives of assets are capitalized. Depreciation expense for the year ended December 31, 2015 was \$4,823.

#### **Marketable Securities**

In accordance with generally accepted accounting principles, the Presbytery reports its investments at market value determined using published quotes as of the close of business. Unrealized gains and losses are included in the statement of activities as increases or decreases in unrestricted net assets unless the use of the assets received is limited by donor imposed restrictions. Donor restricted investment income is reported as an increase in temporarily restricted net assets or permanently restricted net assets, depending on the type of restriction. Gains or losses upon disposition of securities are based on the net proceeds and the adjusted stated amount of the securities sold, using the specific identification method. At December 31, 2015, board designed marketable securities were \$710,901 and permanently restricted marketable securities were \$496,996.

## **Fair Value Measurement**

Generally accepted accounting principles uses a fair value hierarchy that prioritizes the inputs to valuation approaches into three broad levels. The hierarchy gives the highest priority to quoted prices in the active markets (Level 1) and the lowest priority to unobservable inputs (Level 3). Assets and liabilities valued using Level 1 inputs are based on unadjusted quoted market prices within active markets. Assets and liabilities valued using Level 2 inputs are based primarily on quoted prices for similar assets or liabilities in active or inactive markets. Assets and liabilities using Level 3 inputs were primarily valued using management's assessment of the assumptions market participants would utilize in pricing the asset or liability. Valuation techniques utilized to determine fair value are consistently applied. See Note 4 for the valuation in each level.

#### **Restricted Contributions**

The Presbytery receives contributions for a variety of different funds and purposes. The Presbytery reports gifts of cash and other assets as restricted support if they are received with donor stipulations that limit the use of the donated assets. When a donor restriction expires, that is, when a stipulated time restriction ends or restricted purpose is accomplished, temporarily restricted net assets are reclassified to unrestricted net assets. Restricted contributions are expendable only for the purposes specified by the donor and are accounted for as restricted until specified conditions are met.

#### Accounts Receivable and Allowance for Doubtful Accounts

The Presbytery records a receivable for cash advances provided to ministries or churches for which there is an agreement to pay back in full or for costs associated with items or fees for participation and other programs and per capita contributions required from each church in the Presbytery. An allowance for doubtful accounts is provided based on management's best estimate of probable losses inherent in the accounts receivable balance. Management primarily determines the allowance based upon review of specific accounts, historical loss experience, and current economic conditions, then writes off old receivables that are no longer considered collectible. The allowance for doubtful accounts as of December 31, 2015 was \$0.

#### **Accrued Compensated Absences**

Employees are entitled to paid vacation depending upon job classification, length of service, or other factors. Vacations are not cumulative and must be used within the calendar year, except by special provision. Sick pay is also paid but is not accrued since it does not vest. As of December 31, 2015, accrued vacation was \$0.

#### **Federal Income Tax**

The Presbytery is exempt from federal income tax under Internal Revenue Code Section 501(c)(3) except to the extent of unrelated business taxable income, if any.

#### **Contributions Received**

Contributions received are recorded as unrestricted, temporarily restricted, or permanently restricted support, depending on the existence and/or nature of any donor restrictions. Gifts received of long-lived assets, in the absence of donor-imposed use restrictions, are reported as unrestricted support.

Support that is restricted by the donor is reported as an increase in temporarily or permanently restricted net assets, depending on the nature of the restriction. When a restriction expires (that is, when a stipulated time restriction ends or purpose restriction is accomplished), temporarily restricted net assets are reclassified to unrestricted net assets and reported in the Statement of Activities as net assets released from restrictions.

#### **Donated Services and Materials**

The Presbytery recognizes donated services that create or enhance nonfinancial assets. Donated services that require specialized skills, are provided by individuals possessing those skills, and would typically need to be purchased if not provided by donation are also recognized.

The Church has recognized contributed services of \$0 for the year ended December 31, 2015.

#### **Advertising Costs**

Costs of advertising are charged to expense as they are incurred, or when the advertising takes place for the first time, and include costs for production of advertising materials and delivery of advertising messages through the mail or other media. Advertising expenses for the year ended December 31, 2015 were \$0.

#### Note 2 - Concentration of Credit Risk

The Presbytery maintains cash balances at financial institutions located in Washington. Accounts at each institution are insured by the Federal Deposit Insurance Corporation up to \$250,000. Bank balances on deposit in excess of insurance limits were \$437,984 as of the year ended December 31, 2015.

During the year ended December 31, 2015, contributions over \$50,000 made by individuals were \$0. A concentration is defined as any financial transaction or group of transactions or relationships with a contributor, vendor, or other party for which a financial impact would be recognized in the absence of the transactions or relationship for the year under consideration. No other concentrations were identified during the years ended December 31, 2015.

#### Note 3 - Endowments

The Presbytery's endowments consist of \$852,593 in board designated endowments and \$576,137 in permanently restricted endowments as well as \$22,448 of temporarily restricted funds that were established for a variety of Presbytery purposes. The temporarily restricted balance is reduced by the deficit amount caused by declines in market value of the permanent endowment funds because, since the deficit must be replenished, the amount available for distribution classified as temporarily restricted is reduced. As required by generally accepted accounting principles, net assets associated with endowment funds, including quasi endowments, are classified and reported based on the existence or absence of donor imposed restrictions.

#### Permanently Restricted Endowments

Presbytery of the Northwest Coast has eleven funds listed below which are considered permanently restricted endowments. The first three funds belonged to the Presbytery in 2014 and the remaining eight funds were obtained with the merger of the Presbytery of Alaska. The endowment principle for all of these funds is held at Presbyterian Foundation (www.presbyterianfoundation.org), a foundation created to safeguard the long-term financial interest of the Presbyterian Church The Presbyterian Foundation sends quarterly income on these funds to the Presbytery for use in accordance with the donors' restricted purposes.

The Miriam Snow Mathes Memorial Internship Fund is for the purpose of supporting congregations to host a student intern. The intern and internship must include a focus on helping the intern discern whether they may be called to pastoral ministry.

The John and Armenta Merchant Memorial Fund was given for the purpose of supporting small churches in the presbytery with a preference for Neah Bay PC and Clallam Bay PC and for new

church development in the Northwest Coast Presbytery.

The Everson Endowment Fund was given for the purpose of furthering the mission of the Church.

The Phoebe R. Bakken Fund was given to aid mission churches.

Income from the The Lesch Memorial Fund is be to used at the discretion of the Presbytery without restriction.

The Miriam Snow Mathes Internship Fund is to be used only in support of one or more seminary students, to have internship experiences of up to one year in local congregations within the bounds of the Presbytery of Alaska and the Presbytery of Yukon, which is now part of the Presbytery of the Northwest Coast.

The L. Embert and Edith K. Demmert Memorial Fund was established for working with or assisting Native Americans of Southeast Alaska in such ways as the Presbytery shall determine from year to year. If this purpose is no longer practicable, then the Presbytery shall use the said income for such other purposes of need.

Income from the Ruth Allington Memorial Fund is be to used at the discretion of the Presbytery without restriction.

The J. Earl Jackman Leadership Development Fund is to be used for the development of lay pastoral leadership.

The Henry E. Fawcett and Venita E. Fawcett Fund is to be used for expenses related to securing leadership for a seminar program designed to challenge pastors and elders theologically, educationally, and spiritually.

Income from the Mission Fund for the Presbytery of Alaska is to be used for the mission program of the Presbytery of Alaska, now part of the Presbytery of the Northwest Coast, as they shall determine.

Board Designated Community Blessing Fund--The Community Blessing Investment Fund (CBIF) was established by the Presbytery of the Northwest Coast in 2008 with designated purposes. The proceeds of this investment fund can be used by the Presbytery to fund projects and initiatives that pursue one of four purposes:

- 1. To engage, equip, and encourage innovative attempts to develop and expand hands-on ministries that serve the people of our local communities in Christ-like ways.
- 2. To encourage congregations to grow more indispensable to the health and wholeness (shalom) of their communities.
- 3. To embrace new immigrants, people on the margins of white, middle class life, and others at our doorsteps.
- 4. To foster risk-taking innovation in new church development in order to push the boundaries, ideas, and expectations about how God sends new missional communities/congregations into ministry.

The principle of the CBIF can be used to fund capital projects such as property acquisition or loans/equity sharing arrangements in housing for pastors. The fund may also be used for cash flow needs. Its design is flexible and the Finance and Corporate Affairs Committee of the Executive Board of the Presbytery manages this fund through an investment and loan policy.

# Interpretation of Relevant Law

The Executive Board of the organization has interpreted the Washington State Uniform Prudent Management of Institutional Funds Act (UPMIFA) as requiring the preservation of the fair value of the original gift as of the gift date of the donor-restricted endowment funds absent explicit donor stipulations to the contrary. As a result of this interpretation, the organization classifies as permanently restricted net assets (a) the original value of gifts donated to the permanent endowment, (b) the original value of subsequent gifts to the permanent endowment, and (c) accumulations to the permanent endowment made in accordance with the direction of the applicable donor gift instrument at the time the accumulation is added to the fund.

The remaining portion of the donor-restricted endowment fund that is not classified as permanently restricted net assets is classified as temporarily restricted net assets until those amounts are appropriated for expenditure by the organization in a manner consistent with the standard of prudence prescribed by UPMIFA. In accordance with UPMIFA, when in making a determination to appropriate or accumulate donor-restricted endowment funds, the organization considers the duration and preservation of the fund, the purposes of the organization and the donor-restricted endowment fund, general economic conditions, the possible effect of inflation and deflation, the expected total return from income and the appreciation of investments, other resources of the organization, and the investment policies of the organization.

#### **Funds with Deficiencies**

From time to time, the fair value of assets associated with individual donor restricted endowment funds may fall below the level that the donor requires the Presbytery to retain as a fund of perpetual duration. In accordance with generally accepted accounting principles, deficiencies of this nature that are reported in unrestricted net assets were \$79,141 as of December 31, 2015. These deficiencies resulted from unfavorable market fluctuations that occurred shortly after the investment of new permanently restricted contributions by the Presbyterian Foundation. Subsequent gains that restore the fair value of the assets of the endowment fund to the required level will be classified as an increase in temporarily restricted net assets.

# **Return Objectives and Risk Parameters**

All permanently restricted endowment funds are managed by the Presbyterian Foundation and the Presbytery allows the Foundation to use the parameters established by the Foundation to safeguard assets for the Presbyterian Church universal.

## Strategies Employed for Achieving Objectives: Community Blessing Investment Fund

To satisfy its long term rate of return objectives, the Presbytery relies on a total return strategy in which investment returns are achieved through both capital appreciation, realized and unrealized, and current yield, such as interest and dividends. The Presbytery targets a diversified asset allocation that places a greater emphasis on equity securities and debt securities in a 50-50 ratio with a range for each to provide the investment manager flexibility in allocation decisions to achieve its long term return objectives within prudent risk constraints.

The Presbytery has retained Marshall & Sullivan Inc. as an Investment Manager who has worked with Northwest Coast Presbytery since 2009.

# **Spending Policy and How the Investment Objectives Relate to Spending Policy**: Community Blessing Investment Fund

The Presbytery has a policy of appropriating for distribution each year 5% of its Community Blessings Investment Fund's (CBIF) average fair value over the prior 12 quarters through the fiscal year end preceding the fiscal year in which the distribution is planned. In addition the Presbytery may provide up to 10% of the CBIF value for property acquisition in any given year. It may also loan up to 5% for an individual pastor's property acquisition but not exceed a total of 15% of the CBIF value for pastor property loans/agreements. In establishing this policy, the Presbytery considered the long term expected return on its endowment. Accordingly, over the long term, the Presbytery expects the current spending policy to allow its invested funds to grow at an average of 5% annually after its planned payouts. This is consistent with the Presbytery's objective to maintain the purchasing power of the invested assets as well as to provide additional real growth through new gifts and investment return.

The Presbytery guarantees payment on loans and mortgages with various financial institutions to finance the purchase and/or improvements of church facilities for member churches throughout the Northwest Coast Presbytery. These notes are secured by church facilities and are recorded in the name of the congregation or organization which they benefit. Repayment of these notes are made by the member church; however the payments are expressly guaranteed by the Presbytery of the Northwest Coast. At December 31, 2015, the churches of the Presbytery had \$1,293,169 outstanding on these loans, with interest rates ranging from 3.5% to 5.0%. The total 2015 assessed value for tax purposes of the properties was \$7,466,600. The notes have stated maturity dates from one year to thirty years with various terms remaining.

Some loans and mortgages of member churches are not expressly guaranteed by the Presbytery, as the organization does not co-sign the loan forms with the financial institution providing the loans. However, because in the Presbyterian Church (USA) all property is held in trust for the mission of the Presbyterian Church (USA), there is an implied relationship with the mortgages and loans. The notes are secured by church facilities and are recorded in the name of the member congregation. Repayment of the loans is made by the member churches and is not expressly guaranteed by Presbytery. However, there is an implied guarantee through a "trust" covenant. As of December 31, 2015, the churches of the Presbytery had \$10,962,945 outstanding on the loans with interest rates ranging from 4.15-5.75%. The total 2015 assessed value for tax purposes of the properties was \$22,233,705. The notes have stated maturity dates from 10 to 30 years with various terms remaining.

Given the low balances on the outstanding loans in relation to the estimated values of the properties securing them, management believes that the likelihood is remote that the Presbytery would be required to repay the loans.

#### Note 7 - Leases

#### **Operating Leases**

Personal property is leased under operating leases expiring in various years through 2016. Minimum future rental payments under non-cancelable operating leases having remaining terms in excess of one year as of December 31, 2015 for each of the next five years and in the aggregate are:

Operating lease payments and facility lease payments included in expense for the year ended December 31, 2015 were \$16,078. Certain operating leases provide for renewal options for

periods from one to five years at their fair rental value at the time of renewal. In the normal course of business, operating leases are generally renewed or replaced by other leases.

# **Note 8 - Related Party Transactions**

The Presbytery obtained a loan of \$136,500 (see Note 5) to purchase property for a member of its Presbytery. The member pays the mortgage payments directly to the lender on behalf of the Presbytery. The Presbytery records the interest and principal on the mortgage using a noncash transaction with a credit to lease income and a debit to interest expense and the loan payable. Total lease income through December 31, 2015 was \$5,551, total interest expense was \$2,963, and total principal payments were \$2,588.

# Note 9 - Merger with the Presbytery of Alaska

In 2014, the former Presbyteries of North Puget Sound and Alaska concluded they would better meet the needs of the Presbyterian churches in northwest Washington State and southeast Alaska if they merged to form one Presbytery. The surviving corporation was the Presbytery of North Puget Sound and the new entity is called the Presbytery of the Northwest Coast. The merger was implemented on January 1, 2015 and completed by March 2015. As of January 1, 2015, the major classes of assets, liabilities, and net assets of the Presbytery of Alaska and the Presbytery of the Northwest Coast were as follows:

#### Note 10 - Defined Contribution Plan

Employees who are not eligible for the pension plan provided by the Board of Pensions of the Presbyterian Church are eligible to contribute to a 403(b) plan managed by the Board of Pensions. The employees can allocate, at their discretion, up to 20% of their salary to the 403(b) plan and a healthcare flexible spending account. For the year ended December 31, 2015, the amount of retirement plan expense representing contributions made by the Presbytery, not through salary reduction agreements, was \$16,723.

#### Note 11 - Defined Benefit Retirement Plan

All clergy and certain lay employees that are scheduled to work twenty or more hours per week are eligible to participate in a pension plan provided through the Presbyterian Church (USA), which manages the defined benefit retirement plan. Regular pension benefits including supplemental medical benefits are available at age 65 generally and may be available early under disability provisions. For the year ended December 31, 2015, the amount of retirement plan expense representing pension plan payments made by the Presbytery was \$18,363. The funding status as of December 31, 2015 for retirement apportionment in 2016 was 123.7%.

## Note 12 - Subsequent Events

Management considered and found no subsequent events requiring disclosure in the financial statements occurring after the balance sheet date until June 21, 2016, the date the financials were available to be issued, except as follows:

Subsequent to the year ended December 31, 2015, Central Washington Presbytery merged with Presbytery of the Northwest Coast and began operating as one unit.

WHEREAS, According to the *The Constitution of the Presbyterian Church (U.S.A)*, *Part II*, it is my duty as the Stated Clerk of the Presbytery to "... record the transactions of the governing body, keep its rolls of membership ... and furnish extracts when required. .. Such extracts, verified by the Clerk, shall be evidence in any council of the church (G-3.0104);"

WHEREAS, A member of the Birchwood Presbyterian Church of Bellingham, Washington, a member congregation of the Presbytery of the Northwest Coast, donated a parcel of vacant land to the church for unrestricted use; the session (board of trustees) accepted the property and has obtained the congregation's permission at a congregational meeting held on September 4, 2016, to sell it for \$20,000, and place the net estimated proceeds of \$16,184.00 into the church's operating reserves;

#### **RESOLUTION:**
