Presbytery of the Northwest Coast April 17-19, 2015 Maplewood Presbyterian Church, Edmonds, WA

Friday evening, April 17, 2015, an informal discussion was held of the proposed constitutional amendments referred by the General Assembly to the presbyteries for their vote, excluding 14-F, was led by Executive Presbyter Corey Schlosser-Hall and Stated Clerk Dean Strong.

On Saturday, April 18, 2015, the Rev. Kurt Helmcke, whose term as presbytery moderator expired on December 31, 2014, opened the meeting with prayer at 9:05 a.m. He led a service of Installation for Moderator Kathleen Hansen.

A quorum was present¹.

The agenda had been distributed to all commissioners. It contained a special order for addressing proposed amendment 14-F that limited debate and invited two speakers. A motion to adopt the agenda was APPROVED by a vote in excess of the required two-thirds majority.

Worship

Host Pastor the Rev. Barry Keating greeted the presbytery and led worship. The Rev Rev. Claudia Rowe, Pastor of the First Presbyterian Church of Craig and Klawock, preached a sermon on Philippians 2:5-11.

GA Proposed Amendment 14-F. Marriage—On Amending W-4.9000

Guest speakers Rev. Sandy Hackett, Pastor of Lake City Presbyterian Church, of Seattle Presbytery, and Rev. Chris Pritchett, Pastor of John Knox Presbyterian Church, also of Seattle Presbytery, offered a dialogue entitled "Differing Viewpoints"

After Commissioner's comments were heard during a period of discussion and debate, limited to two minutes each, the presbytery voted by ballot. **The motion to adopt the amendment was DISAPPROVED.**

The guest speakers offered a second dialogue entitled *The Amendment has Passed: What is at Stake for Your Congregation? Why and How Can We Serve Together in Mission and Ministry?*

Commissioners were divided into small groups of five representing differing views on same-sex marriage. Each person addressed the two above questions. Some groups shared at the conclusion of this activity; a general theme was an appreciation for the process used to address the proposed amendment.

The morning session was concluded with a celebration of the Lord's Supper; host Pastor Rev. Barry Keating presided.

Lunch Recess

Before lunch, the new regional representative for the Presbyterian Foundation, Rev. Rob Hagen, and the recently appointed Director of Tall Timber, Dave Saugen, were introduced and spoke briefly. The presbytery recessed for lunch.

The meeting reconvened at 1:20 p.m. First time commissioners and elders from other presbyteries were introduced.

Host Pastor Keating spoke about the mission and ministry of Maplewood Presbyterian Church.

Stated Clerk's Report

The minutes of the previous meeting were approved by common consent.

The 2014 Presbytery of the Northwest Coast Statistical Report was received.²

The *Number of Commissioners to Presbytery*,³ as determined by the 2014 Statistical Report, was received.

Several proposed amendments to the bylaws⁴ were received for the presbytery to review before a vote at the next regular meeting.

Proposed Constitutional Amendments

The following proposed amendments to the Constitution, approved by the 221st General Assembly, and recommended to the presbyteries for their vote, were APPROVED:

- 14-B. Special Committee to Review the Preparation for Ministry Process and Standard Ordination Exams;
 - 14-B.1. Final Assessment—On Amending G-2.0607,
 - 14-C. Child Protection Policy—On Amending G-3.0106,
 - 14-D. Minimum Composition of a Presbytery—On Amending G-3.0301.

After discussion and debate, 14-1. Confession of Belhar—Amending the Book of Confessions, was APPROVED.

After discussion and debate, 14.A. Renunciation of Jurisdiction—On Amending G-2.0509, was DISAPPROVED.

After discussion and debate, 14-B.2. Accommodations—On Amending G-2.0610 was APPROVED.

After discussion and debate, 14-E. Interreligious Stance—On Amending G-5.0102 was APPROVED.

Financial Report

Financial statements were distributed with the agenda. Treasurer Bill Grosse briefly discussed the reports.

Executive Presbyter's Report

Dr. Corey Schlosser Hall discussed the closing of the Deming Fellowship and presented a video preview of VERGE 2.0 coming in October.

Executive Board

The Rev. Scott Anthony reported for Moderator Rev. Kurt Helmke who had left earlier to preside at a memorial service. The Minutes of the April 9, 2015, special meeting and the minutes of the March 19, 2015 regular meeting were distributed with the agenda

The following actions were highlighted in the agenda summary:

- Finalization of the final legal documents for the presbytery merger.
- Appointment a task force to negotiate a merger with Central Washington Presbytery.
- Continued planning for VERGE 2.0 in October.

- Dissolution of the Deming Presbyterian Fellowship and the decision to sell the church property.
- Preparations for the E.P.'s summer sabbatical leave.
- Continued discernment regarding the use of asset distributions from the Synod.

<u>Tidelands/Building</u> – The Board reported, through its minutes, that it had authorized a down payment and Mission Development Certificate Program loan to purchase the newly rediscovered former Stanwood Presbyterian Church building as office and worship space for the Tidelands Missional Community in downtown Stanwood. The building has had many former uses. The Rev. Brandon Bailey, Organizing Pastor of Tidelands, told how the opportunity to acquire the facility arose, while photographs of it were shown to the presbytery.

Commission on Ministry

Co-moderator Rev. Hallack Greider reported for the Commission.

Neah Bay/Eastman – The following motion from the Commission was APPROVED: "That Ruling Elder George Eastman be commissioned, to limited pastoral service for three years to the Neah Bay Presbyterian Church, authorizing him to moderate the session, administer the sacraments, officiate at marriages, and exercise the right of voice and vote at meetings of the presbytery, at a Service of Commissioning (G-2.1003) to be held at Neah Bay Presbyterian Church."

<u>Baker/Song</u> – On behalf of the Commission, the Rev. Greider moved, and the presbytery APPROVED the following resolution:

Whereas, The Rev. Peter Song is an ordained member of another Reformed church, and a temporary member of the presbytery for the period of his service (G-2.0506) and requires no further examination having been examined and received May 22, 2013;

Whereas, He qualifies for PCUSA membership under G-2.0505, Transfers of Ministers of Other Denominations, and section (1), immigrant fellowships and congregations;

Whereas, His education exceeds Book of Order requirements, and he passed an equivalent written ordination examination administered by the presbytery;

Whereas, He is serving as temporary Pastor of the Baker Community Presbyterian Church and moderator of the session;

Resolved, That the Rev. Peter Song be declared eligible to serve as the next installed pastor of Baker Community Presbyterian Church, and that an administrative commission be designated to "organize and conduct a service of installation . . . establishing the pastoral relationship."

<u>Myong Sung/Original Jurisdiction</u> On behalf of the Commission, Rev. Greider moved, and the presbytery APPROVED the following resolution:

Whereas, The Rev. Bum Gi Kim completed a year long period of study and preparation for serving in the presbytery and the PCUSA, having been apprised of the current controversies now before the denomination;

Whereas, The Rev. Bum Gi Kim was examined for ordination and membership on November 20, 2014, and was ordained as a teaching elder and installed as pastor of Myong Sung Presbyterian Church on November 30, 2014, vowing to "be governed by our church's polity and abide by its discipline," and "to further the peace, unity and purity of the church;"

Whereas, The Rev. Bum Gi Kim made it known during the period February 9, 2015 to March 17, 2015, in writing and orally, to the session and the presbytery, of his opposition to same sex marriage, and his intention to merge Myong Sung Presbyterian Church with Seattle Korean Presbyterian Church of another Reformed church, by withdrawing from the PCUSA;

Whereas, The presbytery's Commission on Ministry maintained open dialogue and constant communication in accord with G-3.0303 through a series of written communications and meetings with the session and the pastor regarding these matters, delineating how the desires of the pastor, session and congregation could respectfully and peaceably be accomplished by means of the policies and processes of the presbytery, and in a manner maintaining a faithful witness to Jesus Christ to the world;

Whereas, The session voted on March 23, 2015 to "leave the PCUSA due to the passage of Referendum F14" by a majority of the presbyteries, and, after discussing with members of the Commission on Ministry its intention of calling a congregational meeting the purpose of a vote of the members, and after being informed that such a vote was improper business for a congregational meeting, that instead a process of discernment and possible dismissal was appropriate, did call such a congregational meeting on March 29, 2015, moderated by Rev. Bum Gi Kim, and attended by members of the Commission on Ministry, at which time congregational members were asked to and did vote by ballot, without discussion, regarding affiliation with the Presbyterian Church (U.S.A);

Whereas, On March 20, 2015, The Rev. Bum Gi Kim, and three of the four ruling elders: Charlie O, Joongkyu Lee, and June Kim, did renounce the jurisdiction of the Presbyterian Church (U.S.A.), communicating this to the presbytery in writing;

Whereas, The former elders and members of Myong Sung Presbyterian Church have demonstrated great care for the facility and have provided a faithful witness to Jesus Christ in that place, and many have expressed heartfelt expressions of thanks and endearment for the presbytery and the presbytery for them;

Resolved, That the following elders be designated to an Administrative Commission to assume original jurisdiction of Myong Sung Presbyterian Church with the full powers of the session: Rev. Jinsuk Kim, Younghee Kim, Clerk of Session, Rev. Phillip Jang, Rev. James Kwon, Henry Kim, Rev. David Casson.

The Rev. Ki Chun Lee, (see below), designated pastor of Zion Presbyterian Church, was introduced to the presbytery by Associate Executive Presbyter Rev. Jinsuk Kim. The Rev. Lee addressed the presbytery, which welcomed him by the laying on of hands and with prayer.

Delegated Actions Reported to the Presbytery:

<u>Annual Reviews</u> – The work of teaching elders engaged in validated ministries outside the congregation (G-2.0503a(5)) and the status members-at-large teaching elders (G-2.0503b) have been reviewed.

<u>Authorized Ruling Elders/Communion</u> – The following ruling elders have been authorized to administer or preside at the Lord's supper through 2015 at the places indicated: Inga Hanlon, *Yakutat*, Perry Comas, *FPC Sitka*, Sylvester "Sonny" Peale, *Hydaburg*, in the respective congregations; John Taylor, Carol Foss, Rosalie Doty, Paul Stutesman, and Will Garrison, at the assisted living facility *Park View Villas* and at *FPC of Port Angeles* when the Pastor Ted Mattie is unavailable and the session is unable to secure a teaching elder to preach and/or preside in his absence.

Ruling elders Donna Keys, Loretta Klock, and Kim Bowlby have been authorized to administer or preside at *Clallam Bay*, when needed, upon the completion of training by the Rev. Ted Mattie.

<u>Cascade View/Schuldt</u> – The interim contract between Rev. Ted Schuldt and the session was renewed for one year effective March 18, 2015.

Community Church of Seattle/Chung – Rev. Chankil Chung was examined and received as a member

of the presbytery on November 20, 2014. The Commission, which has delegated authority to appoint a commission to install a teaching elder, appointed its own members to ordain and install the Rev. Chankil Chung as Associate Pastor of the Community Church. A service of Ordination and Installation was held at North Creek Presbyterian Church on March 5, 2015.

<u>Mount Baker (Concrete)</u> – The Rev. Wendy Tingley was appointed as Moderator of the Session and Congregation.

Neah Bay/Lee – The call between Rev. Leland Schwartz and the session was dissolved Oct. 31, 2014.

<u>Quilcene/Schaefer</u> – The temporary pastoral relationship between the Rev. Scott Schaefer, HR, and the FPC Quilcene Session was renewed for the period Jan. 1, 2015 through Dec. 31, 2015, according to the following terms: Salary \$27,000, Travel \$1000, Continuing Ed \$600, and Professional Expenses \$400.

<u>Sitka/Gilchrist</u> – A temporary pastoral relationship between the session and Rev. George Gilchrist of Seattle Presbytery was established.

<u>Yakutat/Adams</u> – Rev. Alan Adams, who is the EP of Beaver-Butler presbytery, will serve as temporary supply for six weeks while on sabbatical during June and July.

Zion/Lee – The Rev. Ki Chun Lee was called by the Zion Presbyterian Church. He was examined by the Exam Team who recommended he be received as a member. The Commission invoked Bylaw 9.2000 (vi), which authorizes it to "approve the examination of and receive teaching elders transferring them from other presbyteries and present them at the next stated meeting of the presbytery." The Rev. Lee is a member of good standing in the Northwest Presbytery of the Korean Presbyterian Church Abroad, and was received as a member for the period of his service under G-2.0506. Although Rev. Lee is, in effect, serving as an interim pastor, a minister of another denomination may not moderate the session, so he has been installed, after a vote of the congregation, as pastor as Pastor "for a designated term" and moderator of the session, according to the following terms of call and an option to renew, as needed, for a period of one year beginning January 1, 2015, and as provided by The Orderly Exchange of Ordained Ministers of the Word and Sacrament Under Covenant Agreement Between the Korean Presbyterian Church Abroad and the Presbyterian Church (U.S.A.), Book of Order, Appendix C. He was installed February 15, 2015 by the following Administrative Commission: Rev. Jinsuk Kim, Rev. Tom Patterson, Rev. Hyun Su Baek, Elder Corey Schlosser-Hall, Elder Younghee Kim; Terms of Call: Cash Salary \$18,000, Housing \$18,000, Pension \$7,300, Reimbursable Continuing Education \$1,000, Reimbursable Books \$500, Other Reimbursable Business Expenses \$2,500.

<u>Hinds/Release</u> – At his request, the Rev. Daniel Hinds was released from the ministry as a teaching elder (G-2.0507), as he is no longer engaged in validated ministry. Daniel is a second year medical school student who after graduation will complete a minimum of a three year residency.

<u>Jensen/Winnebago</u> – The Rev. Paul Jensen, HR, was dismissed to Winnebago Presbytery.

Kim/HR – The Rev. Kyoung Kim was designated as Honorable Retired as of December 31, 2014.

¹ (G-2.0505a) A teaching elder may be installed in a pastoral relationship for an indefinite period or for a designated term determined by the presbytery in consultation with the congregation and specified in the call.

Snyder/HR – The Rev. Arden Snyder was designated as Honorably Retired as of April 2, 2015.

Staples/Cascades – The Rev. John Staples, HR, was dismissed to Cascades Presbytery.

<u>Weber/Wyoming</u> – The Rev. Steve Weber was transferred to Wyoming Presbytery where he has accepted a call as temporary pastor of the Presbyterian Church of Jackson Hole.

Commission on Preparation for Ministry

The Rev. Dan Holland, Moderator of the Commission, presented Inquirers Seth Thomas and Matt McCoy for examination to become Candidates for the Ministry of the Word and Sacrament.

<u>Inquirer Seth Thomas</u>, endorsed for Candidacy by the session of the First Presbyterian Church of Bellingham, addressed the presbytery, which examined him further "with respect to Christian Faith, forms of service undertaken, and motives for seeking the ministry." A motion to end the examination was approved, and Mr. Thomas was escorted from the sanctuary. **After discussion, the presbytery APPROVED a motion to move Seth Thomas from the inquiry phase to the candidacy phase of the preparation for ministry process.**

Inquirer Matt McCoy, also endorsed for Candidacy by the session of the First Presbyterian Church of Bellingham, addressed the presbytery, which examined him further "with respect to Christian Faith, forms of service undertaken, and motives for seeking the ministry." A motion to end the examination was approved, and Mr. McCoy was escorted from the sanctuary. After discussion, the presbytery APPROVED a motion to move Matt McCoy from the inquiry phase to the candidacy phase of the preparation for ministry process.

The Rev. Holland administered the questions from the Book of Occasional Service for receiving a Candidate under care to both Candidates. The Rev. Frank Baresel, member of CPM, administered a charge to the Candidates and prayed for them. The presbytery welcomed Candidates Thomas and McCoy.

The meeting adjourned at 3:10 p.m, with a prayer by Moderator Kathleen Hansen. The next regular meeting, which is also the annual meeting, of the Presbytery of the Northwest Coast will convene on Friday, October 16, 2015, at the Community Church of Seattle, Bothell, WA.

Proposed Bylaw Amendments

Presented to the presbytery in writing April 18, 2015, for a vote at the subsequent meeting

Treasurer Term Limits

Currently a three year term and a maximum of six years. This comes from the traditional limits of service for sessions, and formerly COM and CPM. Bill Grosse has already served seven years. The Stated Clerk may serve unlimited terms. Executives have no maximum years of service. Sessions may appoint a treasurer for as long and as many times as they want. The amendments strikes the limit on the maximum number of years.

4.500 Treasurer - A treasurer shall be elected for a term of three years at the last stated meeting of his or her term, and shall assume the duties of the office January 1 following election. No treasurer shall serve consecutive terms, either full or partial, aggregating more than six years. A member having served a total of six consecutive years shall be ineligible for reelection for at least one year.

Stated Meetings & Electronic Attendance

Currently four meetings a year are required. This is the former NPSP pattern. We have already canceled one stated meeting. The amendment strikes the number of meetings per year, two are required by the Book of Order.

"Whenever possible, practical, reasonable attendance by electronic means shall be permitted." Requests have been received from members traveling or on vacation who want to attend electronically, so they do not have to physically attend or schedule personal travel around presbytery meetings. Electronic attendance is intended to lessen the hardship for isolated locations. The amendment restricts electronic attendance to members residences within the bounds of the presbytery, so attendance will not be allowed while on vacation in Hawaii (this was a real request).

6.100 Stated Meetings shall be held in accord with G-3.0105, at least four times a year, and shall constitute meetings of the corporation. One meeting shall be designated as the annual meeting when elections shall occur. The places, dates, times and medium of the stated meetings will be proposed by the Stated Clerk and designated by the Executive Board no later than the third stated meeting of the previous year. Whenever possible, practical and reasonable, attendance by electronic means shall be permitted and provided for commissioners encumbered by a commute time, **from their residence within the bounds of the presbytery**, of at least three hours. . . .

Authorize COM to Commission CRE's

Commissioned Ruling Elders currently must be commissioned at a presbytery meeting. The proposed amendment delegates commissioning ruling elders for pastoral service to COM and allows for a service in a congregation similar to the installation of a teaching elder.

- b. **The Commission on Ministry** is delegated the authority of the presbytery to be "pastor, counselor and advisor to teaching elders and congregations" as delineated in G-3.0307 . . . The following specific tasks are delegated to this commission:
 - xv. When the presbytery's strategy for mission requires it, authorize a ruling elder to be commissioned to limited pastoral service in a validated ministry of the presbytery, according to all provisions of G-2.10, including training, examination, supervision, and withdrawing "commissions for reasons it deems good and sufficient."

d. The commission shall recommend to Presbytery the commissioning of ruling elders to limited pastoral service; instructing, examining, supervising and reviewing them according to G-2.10 of the Constitution.

Authorize CPM to Promote from Inquirer to Candidate

Currently the bylaws require the presbytery to examine and vote on candidacy. The Book of Order no longer requires this. The amendment clarifies the authority of CPM to oversee, manage and supervise the entire preparation for ministry process delineated in G-2.06

9.300 Commission on Preparation for Ministry (CPM)

c. Authority to enroll inquirers, certify a candidate ready for examination for ordination pending a call, and to grant permission to a candidate to enter into negotiations for his or her service (G-2.0607) is delegated to this commission.

The following specific tasks are delegated to this commission:

- i. enroll inquirers,
- ii. determine the phase of inquiry or candidacy,
- <u>iii.</u> grant permission for inquirers or candidates to engage in some form of supervised service to the church,
- iv. authorize inquirers or candidates previously ordained as a ruling elder to preside at the Lord's Supper when invited by a session;
- v. certify a candidate ready for examination for ordination pending a call;
- vi. grant permission to a candidate to enter into negotiations for his or her service (G-2.0607)
- d. The commission shall make a recommendation to the presbytery regarding an inquirer's proceeding to the candidacy phase.

Presbytery of the Northwest Coast October 16-17, 2015 Community Church of Seattle, Bothell, WA

The fourth stated and annual meeting of the Presbytery of the Northwest Coast opened on Friday, October 16, 2015 with a joint service of worship between the Presbyteries of Central Washington the Northwest Coast. The English Ministry Band led a time a music, praise and prayer. Candidate for the Minister of the Word and Sacrament Daniel Jones proclaimed the Word. The Rev. Paul Kim was installed as Associate Pastor of the host church.

The presbytery recessed for an amazing Korean dinner prepared for by the members of CCS. At 7:00 p.m., members of Central Washington Presbytery departed to hold their meeting in another locations. The Presbytery of the Northwest Coast reconvened for discussion, discernment and deciding on the business before it. A quorum was present¹. The agenda had been distributed to all commissioners ten days before the meeting and was approved. The minutes of the April 18, 2015 stated meeting were approved as distributed. Teaching elders visiting from other presbyteries were recognized.

A video was shown about the history, vision and ministry of the Community Church of Seattle.

Stated Clerk's Report

The following proposed amendments to the bylaws had been distributed to the presbytery as part of the agenda at the previous meeting, and were APPROVED (new text underlined and in bold):

(Eliminating Treasurer Term Limits) – **4.500 Treasurer** – A treasurer shall be elected for a term of three years at the last stated meeting of his or her term, and shall assume the duties of the office January 1 following election. No treasurer shall serve consecutive terms, either full or partial, aggregating more than six years. A member having served a total of six consecutive years shall be ineligible for reelection for at least one year.

(Stated Meetings & Electronic Attendance) – **6.100 Stated Meetings** shall be held in accord with G-3.0105, at least four times a year, and shall constitute meetings of the corporation. One meeting shall be designated as the annual meeting when elections shall occur. The places, dates, times and medium of the stated meetings will be proposed by the Stated Clerk and designated by the Executive Board no later than the third stated meeting of the previous year. Whenever possible, practical and reasonable, attendance by electronic means shall be permitted and provided for commissioners encumbered by a commute time, **from** their residence within the bounds of the presbytery, of at least three hours. . . .

(Authorizes COM to Commission CRE's) – b. **The Commission on Ministry** is delegated the authority of the presbytery to be "pastor, counselor and advisor to teaching elders and congregations" as delineated in G-3.0307... The following specific tasks are delegated to this commission:

- <u>xv.</u> When the presbytery's strategy for mission requires it, authorize a ruling elder to be commissioned to limited pastoral service in a validated ministry of the presbytery, according to all provisions of G-2.10, including training, examination, supervision, and withdrawing "commissions for reasons it deems good and sufficient."
 - d. The commission shall recommend to Presbytery the commissioning of ruling elders to limited pastoral service; instructing, examining, supervising and reviewing them according to G-2.10 of the Constitution.

(Authorizes COM to Promote from Inquirer to Candidate) - **9.300 Commission on Preparation for Ministry (CPM)**

c. Authority to enroll inquirers, certify a candidate ready for examination for ordination pending a call, and to grant permission to a candidate to enter into negotiations for his or her service (G-2.0607) is delegated to this commission.

The following specific tasks are delegated to this commission:

- i. enroll inquirers,
- ii. determine the phase of inquiry or candidacy,
- <u>iii.</u> grant permission for inquirers or candidates to engage in some form of supervised service to the church,
- iv. authorize inquirers or candidates previously ordained as a ruling elder to preside at the Lord's Supper when invited by a session;
- v. certify a candidate ready for examination for ordination pending a call;
- vi. grant permission to a candidate to enter into negotiations for his or her service (G-2.0607)
- d. The commission shall make a recommendation to the presbytery regarding an inquirer's proceeding to the candidacy phase.

<u>Proposed Bylaw Amendments</u> – The full text of the following amendments were distributed with the agenda for consideration at the next stated meeting:

- 4.100 Officers' terms of office to last until successors have been elected.
- 4.400 Executive Board moderator elected by the Board from its own members.
- 4.600 Stated Clerk nominated by the Nominating Committee
- 7.000 Membership on Presbytery boards, commissions and committees vacated after two unexcused absences.
 - 8.300 Board composition editorial revision to accommodate 4.400 above.
 - 8.500 Process for calling a special board meeting when the moderator is unavailable or unable.
 - 15.000 Allows amendments to the bylaws by two-thirds vote at any meeting with ten days notice.

Overture to the General Assembly – A motion to send the following overture to the next General Assembly was APPROVED: "That the 221 General Assembly's action on item 05-04, sections 1-4, as amended, be rescinded."

Rationale

The Assembly's action to reduce the number of Synods to "10-12" has proved to be impractical, costly, and unnecessary. Several synods, particularly in the west, have already or are in the process of reducing their functions as provided by G-3.0404, which has, or will, effectively reduce the number of active synods.

These western synods have discussed combining into a single synod, which would achieve the "letter" of the requirement of reducing the number of synods to "10-12," but it would defeat the intention and spirit of the action to reduce the number synods in reality. Furthermore, we have discovered that untangling the assets and legal entities of these reduced functioned synods in order to combine them would be time consuming and costly, while effectively achieving nothing beyond diverting time, energy and resources away from meaningful mission and ministry.

Reduced function in the Synod of Alaska-Northwest occurred at the request of its presbyteries, and it is serving them well. The perception within this synod is that in other regions, presbyteries may be dissatisfied with the actions or functions of their synods, and that a G.A. mandated reduction in the number of synods would somehow solve this problem. Instead, the mandate is creating more tension and issues between and among mid-Councils.

G-3.0404 provides an adequate solution for the "problem" of synods. Synods that function at a high level, providing services and support for their constituent presbyteries should be able to continue

meaningful ministry. Synods that are unable, for whatever reason, to provide this kind of support, that have moved or are moving to reduced function should be allowed to continue without the burden of forced consolidation and restructuring, which will increase the need for more staff and legal fees.

Where synods and their constituent presbyteries disagree on their functions and mutual support, these bodies should do the good and challenging work of finding mutual purpose, ministries and support, instead of foisting their issues on synods who are healthy and fulfilling their "emerging sense of purpose, partnership, context and call."

Myong Sung Administrative Commission – At its stated meeting of April 18, 2015, the presbytery designated an administrative commission to assume original jurisdiction of Myong Sung Presbyterian Church with the full powers of the session. A record of the proceedings of the commission was received and is incorporated into these minutes.²

A resolution "to dismiss the commission with thanks," was APPROVED.

Financial Report

Financial statements were distributed with the agenda. Treasurer Bill Grosse briefly discussed the reports.

Executive Presbyter's Report

A report was received from Dr. Corey Schlosser-Hall on his summer sabbatical leave. He thanked the presbytery for providing this time of rest and renewal, and for being an innovative, creative and partnering presbytery.

Executive Board

The Board Moderator, Rev. Kurt Helmcke, reported. The Minutes of the May 21st regular meeting, the June 15th special meeting and the September 24th regular meeting were distributed with the agenda.

Grants – The following grants were awarded by the Board:

\$20,000 Community Blessing Grant to North Creek PC, Pateros Building Project;

\$7,000 Community Blessing Grant to FPC Everett, to provide for asbestos abatement and repair of space for the Hoff Foundation;

\$25,000 Higher Education Grant to Calvin Community College Outreach to expand the ministry to the combined Cascadia CC/UW Bothell campus.

<u>Selection of Commissioners to General Assembly</u>³ – The Board approved a process for selecting General Assembly commissioners, which includes an application, qualification and election by the presbytery. Since there was inadequate time to allow for applications to be received and distributed to the presbytery for an election at this meeting, applications will be received by the Stated Clerk and the selection will be by the Board, according to the bylaws.

<u>Presbytery Housing Assistance Policy</u> – A policy was adopted for helping congregations determine housing allowances and for determining how the presbytery may assist congregations when housing market disparities might prevent a pastor candidate from accepting a call. The policy will be available in the Manual of Mission and Ministry.

Meeting Schedule⁴ – The tentative schedule for Leadership Summit meetings was approved.

Locations have yet to be determined; technical capacity for on-line attendance will be a factor.

<u>Financial Review</u> – A financial review from Battershell and Nichols, CPAs, was completed and received by the Board, and the recommended accounting procedural changes contained therein were adopted. A final financial review of the former Alaska Presbytery completed by Altman and Rogers, CPAs, was also received by the Board. All financial assets, accounts and records of the two former presbyteries have been merged.

<u>Deming</u> – The following resolution was APPROVED: "*Resolved*, That Janice Smith, Rev. Ted Schuldt moderator), and Shirley Schroeder be designated as an Administrative Commission to settle all of the closing affairs of the Deming Fellowship and former congregation, and that the Commission sell the property to the Mount Baker School District for \$235,000.00, and that Stated Clerk and Corporation Secretary Rev. Dean Strong and/or Corporation President Rev. Kurt Helmcke be authorized to sign any legal documents on behalf of the presbytery related to this sale."

Merger with Central Washington Presbytery – The following resolution was APPROVED: "Resolved, That the Plan and Agreement of Merger between The Presbytery of the Northwest Coast and the Presbytery of Central Washington⁵ be adopted."

The following churches are currently part of the Presbytery of Central Washington and are anticipated to become a part of Northwest Coast Presbytery as of January 1st according to the Plan:

<u>Sitka Sidewalk Easement</u> – The following resolution was APPROVED: "*Resolved*, That the presbytery concur with and approves the action of the session in July of 2015 to grant an easement of the congregation's property to the City/Borough of Sitka for the purpose of constructing a street curb and adjacent sidewalk for public use on the border of the church's property."

<u>2016 Proposed Operating Budget</u>⁶ – The following resolution was APPROVED: "*Resolved*, That the proposed budget be adopted."

Examinations

The Rev. Dennis Hughes reported for the various Examination Teams. Each of the following Teaching Elders and Candidates for Teaching Elder had been examined by a team in accord with the presbytery's policy MMM 4.4210 and each of their responses to the exam questions had been distributed to the presbytery as part of the agenda. After further examination by the presbytery and discussion, a resolution was APPROVED as follows:

"Resolved, That Candidate David Ro of Northwest Coast Presbytery proceed to ordination as Chaplain, Everett Providence Medical Center and be received as a member upon ordination;

Resolved, That <u>Candidate Daniel Jones</u> of Seattle Presbytery proceed to ordination and installation as Associate Pastor of Mountain View Presbyterian Church and be received as a member upon installation;

Resolved, That the <u>Rev. Jon Draskovic</u> of Glacier Presbytery be installed as Pastor of Whidbey Presbyterian Church, and be received as a member;

Resolved, That the <u>Rev. Byeung Kyu Kim</u> of Seattle Presbytery be installed as Pastor of Myong Sung Presbyterian Church, and be received as a member; and

Resolved, That the <u>Rev. Jean Kim</u>, Honorably Retired, of Seattle Presbytery, HR, be received as a member.

The Rev. Doug Bunnell led the presbytery in welcoming these new members with fun, games, gifts, and the laying on of hands and prayers.

Commission on Ministry

Co-moderator Rev. Amy Delaney reported for the Commission.

<u>Daniel Jones Installation</u> – The following resolution was APPROVED: "*Resolved*, That Daniel Jones be installed Sunday October 18th, 4:00 p.m. at Mountain View Presbyterian Church by the following Administrative Commission: Revs. Brandon Bailey, Dean Strong, John Mason (moderator) Stephanie Hankey; Ruling Elders Don Cunningham and Dottie Villesvik.

Commission on Ministry Report

Authorized Actions Reported to the Presbytery:

<u>Baker Community/Song</u> – The Rev. Won Hee (Peter) Song was examined and received as temporary member for a period of service on May 22, 2013. The presbytery approved, by the required 3/4ths vote, that he was eligible to serve as the installed pastor on April 18, 2015, and established the pastoral relationship. COM has designated the following Administrative Commission to install him as Pastor on October 18 at 4:00 p.m.: RE Corey Schlosser-Hall, TE Jinsuk Kim, TE Paul Strawn, RE Young Hee Kim, TE Chan Kil Chung, TE Philip Jang.

Community Church of Seattle/Kim – The Rev. Paul Kim was called as an Associate Pastor and began work on August 17, 2014. He was examined by the presbytery and received as member September 26, 2014. At the request of the session, COM has approved a request to conduct a service of installation during worship at the October 16th stated meeting of the presbytery.

<u>Maplewood/Keating</u> – Rev. Barry Keating resigned as Pastor of Maplewood and accepted a position at Evergreen Hospital as Chaplain beginning June 22nd. COM concurred with a congregational vote to dissolved the call on June 4, 2015; his category of presbytery membership was designated as "engaged in a validated ministry beyond the jurisdiction of the church (g-2.0503)." Rev. Dean Strong was appointed as moderator of the session.

<u>Maplewood/Greider</u> – A temporary pastor agreement between the session and the Rev. Hallack Greider, beginning October 11, 2015 was approved by the Commission. The agreement allows for the session, COM, and the temporary pastor to make a determination at six months whether he could become a candidate for the installed position (which requires a 3/4th vote of the presbytery).

<u>Metlakatla/Emery</u> – Metlakatla has been experiencing financial difficulties. COM approved the following changes to Pastor Larry Emery's terms of call:

Salary and Housing:

- a. Salary to be reduced \$600 per month, October 2015 January 2016, from \$2,917 per month to \$2,317 per month.
- b. Pastor will be free from duties from Thursday morning through Friday, to return on Friday evening each week.
- c. All other terms to remain as written in the current terms of call.

Mountain View/Jones – The congregational voted to call Candidate Dan Jones of Seattle Presbytery as Associate Pastor May 31st. COM approved the terms of call below, and approved Mr. Jones beginning to work in a non-ordained status, if the recommendation of an exam team was that he be examined and received as a member at the next stated meeting of the presbytery. <u>Port Townsend/Heins</u> – Rev. Paul Heins was called by the First Presbyterian Church of Port Townsend in April, and was not able to attend the April presbytery meeting. In order that he might take office before the October meeting, he was examined by a team, and by all of COM, who received him as a member of the presbytery on May 7, 2015 (according to the bylaws, COM has authority to examine and receive new

members but it normally refers the final vote to the presbytery). He was also appointed as moderator of the session until his installation. The following terms of call were approved:

Owen – The Rev. John Owen has recently retired from the Navy and he is now living in Spokane. His membership status has been designated as Member-at-Large.

<u>Saint James/Hauerwas</u> – The Rev. Rev. Jon Hauerwas accepted a call as Pastor of Westminster Presbyterian Church in Akron, OH. COM concurred with the congregation, dissolve the call with Saint James, and transfer him to Eastminster Presbytery effective Sept. 1st. The session is currently searching for an interim pastor.

<u>Sitka</u> – George Gilchrist was appointed as moderator of the session.

Whidbey/Greider – The interim contract between the session which expired July 15 was extended to August 31st.

<u>Whidbey/Draskovic</u> – The Rev. Jon Draskovic was called by vote of the Whidbey congregation on May 24th. He was examined by a team on May 22nd. COM approved the terms of call, and approved service to begin on September 14th based on the team's recommendation was that he be received as a member. A date for installation has yet to be determined by an Administrative Commission to be designated by COM. Terms of call:

<u>Yakutat</u> – Ruling Elders Virgina Demmert, Evelyn Dierick, and Coral Mills have been approved to preside at the Sacrament of the Lord's Supper as needed until a pastoral relationship is establish by the presbytery with a teaching elder or commissioned ruling elder.

For Information

<u>COLA for Teaching Elders</u> – **The 2016 recommended COLA for Teaching Elders is .5%.** The annual reports by the Board of Trustees for the Social Security Trust Funds is currently forecasting no cost

of living adjustment for Social Security recipients payable in January 2016. The Personnel Committee suggested a 2016 COLA for presbytery staff of SS COLA +.5%.

<u>Mukilteo</u> – A team has been working for several months with the session of Mukilteo to discern whether they should remain a part of the presbytery or seek dismissal to another Reformed body. The report below was provided to COM and the session.

- 1. We recognize that the period of discernment has concluded, and that the MPC session has made its decision to seek dismissal.
- 2. A poll was recently conducted by the session to provide them with information that it may have needed to affirm their decision. The presbytery did not participate in the administering of the poll as part of the presbytery's approved process, and the poll does not provide information that presbytery will need to make a decision about a dismissal that may include property. The presbytery will survey the congregation again, using an independent statistician and variety of means, to obtain the information it needs to consider its strategy for mission and the question of dismissal with property.
- 3. It is affirmed that the session has the right to renounce the jurisdiction of the PCUSA at any time, and constitute a church, with whoever might attend, at another location, at any time. The session's decision to renounce PCUSA's jurisdiction but request to retain its current property would result, if that request is granted, in that property is no longer available to further the mission of the PCUSA. The seriousness of this consequence must be adequately considered.
- 4. The Presbytery must further assess the state of the congregation in order to determine its strategy for mission and to abide by the Constitutional provisions addressing churches who wish to be dismissed to another Reformed Body: *G-4.0207 The relationship to the Presbyterian Church (U.S.A.)* of a congregation can be severed only by constitutional action on the part of the presbytery (*G-3.0303b*). If there is a schism within the membership of a congregation and the presbytery is unable to effect a reconciliation or a division into separate congregations within the Presbyterian Church (U.S.A.), the presbytery shall determine if one of the factions is entitled to the property because it is identified by the presbytery as the true church within the Presbyterian Church (U.S.A.). This determination does not depend upon which faction received the majority vote within the congregation at the time of the schism.

Although the above language requires the presbytery to determine if a faction "is entitled to the property," more practically speaking, the presbytery must determine what its future strategy for mission in Mukilteo will be, and how that strategy will be affected by the current property. The presbytery must not necessarily award the property to a "faction," but has the option to dismiss the congregations to another Reformed body, with the property, while also providing a PCUSA witness in the area, and providing for current Mukilteo members who wish to remain PCUSA members a body for their Christian witness and work. Potential strategies are located along a spectrum, with many midrange options, that ranges from assuming original jurisdiction of the session and dissolving the call with the current pastor to be replaced by a new pastor and session, to dismissing the pastor, session and congregation to another Reformed body with the property. If the latter option is recommended, a value must be established for the property that includes the value of presbytery's total investment over the life of the congregation, tangible and intangible. Compensation for this investment is a requirement of any dismissal agreement.

5. While we value our past, present and future relationships with MPC, COM has decided that an official "Affiliate" membership agreement would be of limited value and difficult to create and maintain since there is no constitutional category and precedent for affiliate membership. Therefore any future relationship, and the terms for possibility of a future re-affiliation with the presbytery, can be

included in a dismissal agreement should this be mutually desired by the parties.

- 6. An application for dismissal has been requested from the session. The presbytery has provided the application, which includes questions relating to and rationale for dismissal. The application will be distributed to the presbytery membership as part of their decision making process, as they alone have the authority to dismiss a congregation.
- 7. The presbytery will hold a congregational meeting to explain the process, provide a rationale for continued presbytery membership, further assess the state of the congregation, and begin the gathering of information mentioned in #2 above. The Executive Presbyter will be among the presenters at this meeting, so it will not occur until after he returns from sabbatical leave in September.
- 8. The process of a dismissal will not reach a stage where a vote of the presbytery could be obtained by the October 16th stated meeting. Once COM has conducted all of the above, it will make recommendation to the presbytery.
- 9. COM has dismissed the discernment team with thanks now that the period of discernment is over, and the session has made a decision to seek dismissal. A second team will now be formed from COM, the Executive Board, or other members of the presbytery to address the different issue of assessing assess the possibilities and options for a PCUSA/NWCP congregational witness in Mukilteo (Bylaw 8.600 The Executive Board has the responsibility and power . . . To encourage, coordinate, resource and fund emerging mission common to the Presbytery, including the development of new and existing congregations, in response to the needs or ministry interests expressed by its members, commissioners and churches within the principles established in Scripture, the Constitution, and according to these Bylaws)
- 10. Once a strategy for future ministry has been determined, this team can make a recommendation to the presbytery regarding the use of the property and any possible settlement that might be made if the property is to be retained by the dismissed congregation. Normally an Administrative Commission is designated to negotiate and/or execute a settlement, once the presbytery has voted on a final recommendation.

Commission on Preparation for Ministry

The Rev. Dan Holland, moderator of the commission, reported.

Inquirer Shannon Smythe was presented to the presbytery for examination in order to be received as a candidate. She made a statement, answered several questions from the presbytery, and was excused. After discussion, the following resolution was APPROVED: "*Resolved*, That upon successful completion of an examination by the presbytery 'with respect to Christian Faith, forms of service undertaken, and motives for seeking the ministry,' Inquirer Shannon Smythe, who is endorsed by the session of the First Presbyterian Church of Bellingham, be received as a Candidate for the Ministry of Word and Sacrament.

Moderator Kathleen Hansen administered the constitutional questions to the Candidate. The Rev. Dan Holland delivered a short charge and prayed for Candidate Smythe.

Myong Sung Administrative Commission Report to the Presbytery - October 16, 2015

At its stated meeting of April 18, 2015, the presbytery designated the following elders as an Administrative Commission to assume original jurisdiction of Myong Sung Presbyterian Church with the full powers of the session: Rev. Jinsuk Kim, Younghee Kim, Clerk of Session, Rev. Phillip Jang, Rev. James Kwon, Henry Kim, Rev. David Casson.

On May 7th, the AC reported the following to COM: "Rev. Jinsuk Kim is preaching through May. The intent is to rebuild the church: Options: 1) CCS may recolonize; 2) combine with Agape and search for a new pastor since he will retire soon, 3) hold the building for a community center/use, 4) sell the building and use the proceeds for mission. Currently option #1 seems most viable."

On June 4th, the AC Moderator Rev. David Casson filed the following report with COM and the Executive Board: "The Administrative Commission for Myong Sung church met on April 8, April 23 and May 14. The remaining congregation, while small (around 10) continues to meet for Sunday worship, led by Jinsuk Kim. The congregation will likely not meet for three weeks in June due to vacations of both attending families. With the help of Presbytery the congregation continues to meet its financial obligations. The recent sale of a car owned by the church will mean the church needs no money from Presbytery during June or July. At our May 14th meeting we considered some promising scenarios in which one or more Korean congregations send leadership and members to re-invigorate the Myong Sung church. We had hoped to settle on one of these options, but we really felt we could not finalize a strategy with elder Henry Kim and Rev. Philip Jang absent from the meeting. We are hoping a short meeting on Friday, April 22nd will give us that opportunity."

On Sept 2, the AC reported the following to COM: The AC/session met and considered three alternatives for the use of the property. They accepted an offer from Glory PC, of Seattle Presbytery, to merge by having the members of Glory join Myong Sung,k effective Sept. 1. The session/AC received the entire congregation st of Glory by Letter of Transfer. They called a congregational meeting, elected a PNC, who nominated the Rev. is Byeung Kyu Kim, Pastor of Glory PC to be the Pastor of Myong Sung P.C. The congregation voted to elect the Rev.Kim as their pastor.

The Executive Board has paid the \$5,000 mortgage payment for Myong Sung for the months of April and May. Myong Sung made the payments for June and July with the proceeds of the sale of the formerpastor's automobile. The AC/session has requested the Board to pay the August payment, which is due bySeptember 1st . Two attempts to call a Board meeting were unsuccessful. The Board has asked COM to review the entire situation and make a request to the Board, including an accounting of the merged church's total assets, which was not included in the information provided to the Board. The AC requested Glory to loan Myong Sung \$2,500 for the August payment, before the merger took place and Glory PC agreed; the August payment was made on time. The merged church has made the September payment. COM is requesting that the \$2,500 loan be repaid to the church.

The AC requested the annual terms of call between Myong Sung and Pastor which were previously accepted by Seattle Presbytery where he served as Pastor of the Glory Church, be accepted by COM.

A session of ruling elders and a moderator has been constitutionally reconstituted, and the Commission requests that they be dismissed.

(Stated Clerk's Note: COM conducted a full financial review of the merged church, and recommended to the Executive Board that the \$2,500 loan be repaid; the Board agreed. COM also approved the terms of call, see the COM report.)



Election of GA Commissioners and Young Adult Advisory Delegates 222nd (2016) General Assembly

The Presbytery of the Northwest Coast is entitled to two (2) ruling elder commissioners and (2) teaching elder commissioners. The processes for selecting commissioners from the predecessor presbyteries are no longer relevant, no longer workable, and in some cases, unconstitutional.

The process below strives to respect three Presbyterian Principles:

- 1) "the election of the persons to exercise authority, in any particular society, is in that society." [F-3.0106]
- 2) "Presbyters are not simply to reflect the will of the people, but rather to seek together to find and represent the will of Christ." [F-3.0204]
- 3) "The Presbyterian Church shall guarantee full participation or representation in its worship, governance, and emerging life to all persons or groups within its membership." [F-1.0403]

Since there was insufficient time for an election at the presbytery meeting, the Executive Board will make the selection according to the Bylaws.

Selection Criteria

Teaching Elder (two)

- a. Membership in good standing and residency for at least two years.
- b. Previous Service Has not served as a G.A. Commissioner for ten years.
- c. Service to the Presbytery one or more of the following conditions:
 - i. At least 50% attendance at stated Presbytery meetings for the past two years.
 - ii. Current or recent service on a Commission or Committee of the Presbytery (COM, CPM, Executive Board, Nominating) with consistent attendance and participation.
 - iii Current or recent service to a higher council of the church.
- d. <u>Congregational Participation</u> Active participation in the life of a member congregation if not a pastor or associate pastor (e.g. regular worship attendance, adult education, etc.)
- e. <u>Representation</u> Whenever one of the following categories has not been represented for three successive Assemblies, one of the teaching commissioners will be elected from that category unless no qualified teaching elder (including those above) is willing to serve.
 - (1) Gender
 - (2) Age group: under/over age of 50
 - (3) White/non-white
 - (4) Geography: Alaska/Washington

Ruling Elder - Two; one male, one female.

- a. From a church represented at least 75% of stated meetings for prior two years.
- b. Congregation has not sent a Ruling Elder commissioner to three previous assemblies.
- c. Service to the Presbytery one or more of the following conditions:

- i. Has attended presbytery at least twice during the previous two years.
- ii. Current or recent service on a Commission or Committee of the Presbytery (COM, CPM, Executive Board, Nominating), with consistent attendance and participation.
- iii Current or recent service to a higher council of the church.
- d. Must be endorsed by his or her session.
- e. <u>Representation</u> Whenever one of the following categories has not been represented for three successive Assemblies, one of the teaching commissioners will be elected from that category unless no qualified teaching elder is willing to serve.
 - i. Age group: under/over age of 50
 - ii. White/non-white
 - iii Geography: Alaska/Washington

Young Adult Advisor Delegates – Required:

- 1. Between the ages of seventeen and twenty-three as of June 18, 2015.
- 2. An active adult and/or confirmed member of a congregation.

PLAN AND AGREEMENT OF MERGER between THE PRESBYTERY OF NORTHWEST COAST and THE PRESBYTERY OF CENTRAL WASHINGTON

[The Presbytery of Central Washington approved this item October 16, 2015.] [The Presbytery of Northwest Coast approved this item below, October 16, 2015.]

PREAMBLE:

CENTRAL WASHINGTON
Overwhelming challenges
Welcomed, encouraged, not alone
God's hand upon us;
Wonder and excitement arise!

NORTHWEST COAST
Prayerful anxiety
Still, roads we know!
Faithful obedience
Oh My! God is leading us to this!

What will God do next?

Both Central Washington and Northwest Coast Presbyteries recognize the needs and challenges ahead. Both recognize the opportunity to engage, equip and encourage people and congregations to make disciples for Jesus Christ in new passionate and creative ways. Therefore we eagerly seek to respond to God's call in faith to unite in one community. Blessed with people across mountains, and waterways; people of different cultures and languages; people of diverse understandings; all of us seek together to follow Christ our Savior.

THIS PLAN AND AGREEMENT OF MERGER by and between the Presbytery of Central Washington of the Presbyterian Church U.S.A., a non-profit corporation, (hereinafter the "Disappearing Corporation & Presbytery"), and the Presbytery of Northwest Coast of the Presbyterian Church U.S.A., a non-profit corporation (hereinafter the "Surviving Corporation & Presbytery," or the "Merged Presbytery"), said corporations and presbyteries being together hereinafter sometimes called the "Constituent Corporations" or the "Constituent Presbyteries."

WHEREAS, the Disappearing Corporation and Presbytery is a Washington corporation duly organized, validly existing and in good standing as a non-profit corporation under the laws of the State of Washington, a representative Council of the Presbyterian Church U.S.A; a corporate expression of the church consisting of all the churches and Ministers of the Word and Sacrament within the following district: The geographical territory of the Presbytery includes the counties of Okanogan, Chelan, Douglas, Grant, , Kittitas, Yakima, Benton, Franklin, Walla Walla, that part of Adams known as the Panhandle, and that part of Klickitat east of Rock Creek, all of said counties lying within the state of Washington

WHEREAS, the Surviving Corporation is a Washington corporation duly organized, validly existing and in good standing as a non-profit corporation under the laws of the State of Washington and the State of Alaska, a representative Council of the Presbyterian Church U.S.A; a corporate expression of the church consisting of all the churches and Ministers of the Word and Sacrament within the following district: The geographical territory of the Presbytery shall include the counties of Clallam, Jefferson, Island, San Juan, Skagit, Snohomish, Whatcom, and those portions of King County north of NE 160th Street, Seattle, Washington; and within the following district of the State of Alaska including the organized and unorganized boroughs and cities of Yakutat, Haines, Skagway, Juneau, Hoonah-Angoon, Petersburg, Wrangell, Sitka, Prince of Wales-Hyder, and Ketchikan.

WHEREAS, the Council and Directors of the Disappearing Corporation and Presbytery, and the Executive Board and Directors of the Surviving Corporation and Presbytery deem it advisable and for the best interest of the respective Constituent Presbyteries and Corporations, and their respective voting members have by the requisite majority vote agreed, that the two corporations and presbyteries be merged in the manner and upon the terms and conditions hereinafter set forth;

WHEREAS, this agreement is subject to the approval of the Synod of Alaska-Northwest, which has the sole authority to unite or otherwise combine presbyteries or portions of presbyteries previously existing, subject to the approval of the General Assembly of the Presbyterian Church (U.S.A.); approval of which the constituent presbyteries do hereby request;

NOW, THEREFORE, for and in consideration of the premises and the mutual agreements set forth below, and for the purpose of effecting such a merger and prescribing the terms and conditions thereof in accordance with the applicable provisions of the Constitution of the Presbyterian Church (U.S.A.), and the Non-profit Corporation Act of the State of Washington, the Constituent Corporations do hereby agree as follows:

- Section 1. **Transition Period.** The merger of the Disappearing Corporation with the Surviving Corporation provided for in this Agreement shall become effective January 1, 2016, and a period of transition shall exist until December 31, 2016. All applications, filings, notifications, constitutional requirements (including a revised Manual of Operations) and processes for this merger, including revising the State of Washington Articles of Incorporation (RCW 24.03) shall be complete by December 31, 2016.
- Section 2. **Merged Governance & Name.** On the effective date (as defined in Section 1) the Disappearing Corporation and Presbytery shall be merged with the Surviving Corporation and Presbytery, and the surviving corporation shall be known as the Presbytery of (----to be determined------), (the "Surviving Corporation"), governed by the laws of the State of Washington and the Constitution of the Presbyterian Church (U.S.A.).
- Section 3. **Bylaws.** The Bylaws of the Surviving Corporation and Presbytery as in effect on the day prior to the Effective Date, shall remain effective and shall remain as the Bylaws of the Merged Presbytery. This Plan of Agreement and Merger shall remain in effect until the amended bylaws of the Merged Presbytery shall be approved by the members of the Presbytery of Central Washington as provided in the Presbytery of Central Washington Bylaws 10.01 and by the members of Northwest Coast Presbytery as provided in Bylaws 3.000 and 15.000 of the Northwest Coast Presbytery Bylaws.
- Section 4. **Executive Board Representation.** The Executive Board shall include at least one additional member to be elected by the members of the Presbytery of Central Washington. The agenda of regular Board meetings shall always include an item "Central Washington Business." During the period of transition, or until the offices cease to exist, the Executive Presbyter to the Presbytery of Central Washington and the Stated Clerk of the Presbytery of Central Washington shall be members of the Executive Board without vote.
- Section 5. **Transition Period Management & Administration.** The Council of the Presbytery of Central Washington will assume during the Transition Period the following responsibility and powers in relation to the members and affairs of the Presbytery of Central Washington, as provided by the bylaws of the Merged Presbytery, and will develop and implement a plan for integration of these responsibilities and powers previously held by the Constituent Presbyteries and Corporations in order to accomplish the merger:
 - a. Manage the Disappearing Presbytery's Finances and Corporate Affairs, including
 - (1) Recommending an inclusive annual budget to the Merged Presbytery prior to the beginning of Fiscal Year 2016, including the 2016 presbytery per capita for the churches of the Presbytery of Central Washington.
 - (2) Authorizing revisions or exceptions to the Presbytery of Central Washington's portion of the Merged Presbytery's approved budget,
 - (3) Managing the Disappearing Presbytery's accounts, reserves, holdings, investments, insurance, legal matters of the Presbytery; funding for travel, and all other pertinent corporate and financial business of the Presbytery
 - (4) Providing the Merged Presbytery with an annual report of all financial and corporate matters;

- b. Provide for the administration of the program and responsibilities of the disappearing Presbytery;
- c. Provide for and fund an appropriate decision making process and/or regional gatherings for the members of the former presbytery, including logistics, as needed;
- d. By state law, the Surviving Corporation is to obtain title to all assets owned by the Disappearing Corporation and the Surviving Corporation assumes all debts owed by the Disappearing Corporation;
- e. Identify funds or assets donated and designated for a specific use, determine how to honor the intent of the donors;
- f. Identify and develop a plan, including the necessary funding, for the continuation of historical and critical ministries previously administered by the Presbytery of Central Washington. The Presbytery of Central Washington continues to value, and places a high priority on, the successful ministry at both The Campbell Farm and Tall Timber Ranch. The merged presbytery will explore with The Campbell Farm and Tall Timber Ranch the most effective strategies for their continued ministries;
- g. Recognizing in (d) and (e) above, that funds held by the Presbytery of Central Washington were solicited and received for administrative operations of the presbytery and mission within its bounds.
- Section 6. **The Commission on Ministry** shall include at least one elder member from the Presbytery of Central Washington. COM shall appoint a liaison to each Central Washington church, from members of the Presbytery of Central Washington whenever possible.
- Section 7. **Examination of Teaching Elder and Commissioned Ruling Elder Members.** Teaching Elders and Commissioned Ruling Elders who are members of the Disappearing Presbytery on the effective date of this agreement shall become members of the Surviving and Merged presbytery without further examination as required by G- 3.0306. Teaching Elders and Commissioned Ruling Elders called to a congregation of the Presbytery of Central Washington, seeking membership in the merged presbytery after the effective date of this agreement, shall be examined according to MMM 4.4201, except that the Exam Team shall include at least one elder who is a member of the Presbytery of Central Washington.
- Section 8. **The Commission on Preparation for Ministry** shall include at least one member of the Presbytery of Central Washington, to be named by the Presbytery of Central Washington. Inquirers and Candidates enrolled at the effective date of this agreement will become enrolled in the merged presbytery.
- Section 9. Staff. For the period of transition, staff shall include the Reverend Kevin Nollette, to be paid by the Presbytery of Central Washington in accordance with the service contract with Seattle Presbytery, from 1 January 2015 through June 2016. Ruling Elder Michael Nixon will serve and function as the Stated Clerk for Central Washington congregations for the period of transition. The Stated Clerks of the constituent presbyteries will propose amendments and revisions as delineated in Sections 1 and 3.
- Section 10. **Meetings.** At least one face-to-face presbytery meeting will be held during the period. Whenever possible, amendments to any governing documents affecting both of the constituent presbyteries, overtures to the General Assembly, and examinations of teaching elders will be addressed during face to face meetings. Attendance at all meetings may be possible via electronic means. The Presbytery of Central Washington Council will provide travel funds in accordance with its existing policies throughout the transition period of the merger, i.e., expenses of persons serving on administrative units of the Presbytery shall be reimbursed as budgeted. Expenses of commissioners to Presbytery meetings shall be paid by the churches. Exceptions shall be approved by the PCW Council.
- Section 11. **Permanent Judicial Commission.** The Merged Presbytery shall have a single Permanent Judicial Commission (PJC) as of the effective date consisting of the members of the Constituent Presbyteries

commissions. Members shall serve out their previously elected terms. The Merged Presbytery shall conform to the requirements of the *Rules of Discipline* (D-5.0100) regarding election, terms, classes, vacancies and eligibility.

- Section 12. **Cancellation.** Notwithstanding anything herein to the contrary, if the Council of the Presbytery of Central Washington or the Executive Board of the Presbytery of Northwest Coast should determine at any time prior to the Effective Date, and shall so notify the other in writing, that for any legal, financial, economic, or business reason deemed sufficient by either Board it is not in the best interests of that Constituent Corporation and Presbytery and its members, or is otherwise inadvisable or impracticable, to consummate the merger, said Board may terminate and abandon the merger, and thereupon this agreement shall be void and of no effect.
- Section 13. Amendment. At any time prior to the Effective Date, this Agreement may, by an instrument in writing, be amended by mutual consent of the Council of the Disappearing Corporation and the Executive Board of the Surviving Corporation to the extent permitted by Washington law. Prior to the Effective Date, the Constituent Corporations and Presbyteries shall take, or cause to be taken, all such action as may be necessary or appropriate in order to effectuate the Merger. If at any time after the Effective Date any further action is necessary or desirable to carry out the purpose of this Agreement and to vest the Merged Presbytery with full title to all assets, properties, rights, privileges, powers, immunities or obligations of either of the Constituent Corporations, the Constituent Corporations shall take all such necessary and appropriate action as the Board of Directors of such Constituent Corporation may determine.
- Section 14. This Agreement shall be governed in all respects, including validity, interpretation, and effect, by Constitution of the Presbyterian Church (U.S.A.) and the laws of the State of Washington.

IN WITNESS WHEREOF, this Agreement of Merger has been duly executed by the Stated Clerk and Secretary of the Disappearing Corporation and Presbytery and the Stated Clerk and Secretary of the Surviving Corporation and Presbytery, thereunto duly authorized by resolutions adopted by at least a majority vote of all the members of the constituent presbyteries.
